Pursuant to D.C. Official Code §2-352.02(a) (2011 Repl. & Supp.), enclosed for consideration and approval by the Council of the District of Columbia is the proposed legislation, "Johnson Controls Security Solutions LLC, Contract Approval Resolution of 2018" to approve a multi-year contract with Johnson Controls Security Solutions, LLC. The proposed period of performance is the Base Term for two (2) years commencing on date of award, with four (4) one-year renewal Option Periods. The dollar value of the proposed contract is \$4,388,235 for the Base Term.

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve multiyear Contract No. SO-18-011-0001714 with Johnson Controls Security Solutions, LLC ("**Johnson**") to provide a turnkey digital IP surveillance camera system and supporting network equipment, preventative maintenance, system repairs and emergency services at the Walter E. Washington Convention Center.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Johnson Controls Security Solutions, LLC Approval Resolution of 2018"

Sec. 2. (a) The Washington Convention and Sports Authority, t/a Events DC, proposes to enter into a two (2) year agreement with four (4) one-year options with Johnson for surveillance camera system services for a base term price of \$ \$4,388,235.

(b) The services to be provided under this contract are for removal of an existing analog system, furnishing, installing, programming and testing the new digital IP surveillance camera system and supporting network equipment, managed video service software and support, on-site training, preventative maintenance, routine repairs and emergency services.

Sec. 3. Pursuant to section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code §1-204.51(c)(3)), the Council of
