The Council of the District of Columbia reappoints: Elizabeth C. Mohler Van Ness Street, N.W. Washington, DC 20008 (Ward 3) as a member of the Citizen Review Panel, established by section 351 of the Prevention of Child Abuse and Neglect Act of 1977, effective April 12, 2005 (D.C. Law 15-341; D.C. Official Code § 4-1303.51), for a term to end April 11, 2024. Sec. 3. The Council of the District of Columbia shall transmit a copy of this resolution, upon its adoption, to the appointee, the chairperson of the Citizen Review Panel, and to the Office of the Mayor.
