

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Contract No. CW93185 with Genuine Parts Company dba NAPA, and Modification Nos. 15, 16, 17, and 18 to Contract No. CW93185, and to authorize payment for the goods and services received and to be received under the contract and modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modification Nos. 15, 16, 17, and 18 to Contract No. CW93185 with Genuine Parts Company dba NAPA Approval and Payment Authorization Emergency Declaration Resolution of 2024”.

Sec. 2. (a) There exists an immediate need to approve Contract No. CW93185 with Genuine Parts Company dba NAPA, and Modification Nos. 15, 16, 17, and 18 thereto, and to authorize payment for the goods and services received and to be received under the contract and modifications.

(b) On July 17, 2024, by Modification No. 15, the Office of Contracting and Procurement (“OCP”), on behalf of the Fire and Emergency Medical Services Department (“FEMS”), partially exercised option year three of Contract No. CW93185 with Genuine Parts Company dba NAPA to provide operational and logistical management, inventory control, and vehicle parts for

34 the period August 6, 2024 through September 30, 2024, in the not-to-exceed amount of
35 \$467,000.

36 (c) On August 29, 2024, by Modification No. 16, OCP, on behalf of FEMS, extended the
37 partial exercise of option year three through October 15, 2024, at no additional cost.

38 (d) On October 1, 2024, by Modification No. 17, OCP, on behalf of FEMS, extended the
39 partial exercise of option year three through November 15, 2024, and increased the not-to-exceed
40 amount of option year three by \$375,000, from \$467,000 to \$842,000.

41 (e) Proposed Modification No. 18 would exercise the remainder of option year three
42 through December 29, 2024, and increase the not-to-exceed amount by \$1,158,000, from
43 \$842,000 to a total not-to-exceed amount of \$2,000,000.

44 (f) Under section 451(b)(1) of the District of Columbia Home Rule Act, approved
45 December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)(1)), Council approval is
46 necessary as Modification No. 18 will increase the value of the contract to more than \$1 million
47 during a 12-month period.

48 (g) Approval is necessary to allow the continuation of these vital services. Without this
49 approval, Genuine Parts Company dba NAPA cannot be paid for goods and services provided in
50 excess of \$1 million for the period from August 6, 2024, through December 29, 2024.

51 Sec. 3. The Council determines that the circumstances enumerated in section 2 constitute
52 emergency circumstances making it necessary that the Contract No. CW93185 with Genuine
53 Parts Company dba NAPA Approval and Payment Authorization Emergency Act of 2024 be
54 adopted after a single reading.

55 Sec. 4. This resolution shall take effect immediately.
