Be It Enacted by the Legislature of the State of Florida: Section 1. Extension of Acme Improvement District boundaries.-The lands commonly known as the "Wellington Medical Arts District," more particularly described below, shall be added to the territorial limits of the Acme Improvement District, a dependent district of the Village of Wellington, existing in Palm Beach County, as codified under chapter 2003-330, Laws of Florida, and shall be removed from the territorial limits of the Lake Worth Drainage District, a corporation under the drainage laws of the state, existing in Palm Beach County, as codified under chapter 98-525, Laws of Florida. The purpose of the transfer of property from the Lake Worth Drainage District to the Acme Improvement District is to facilitate the development of the Wellington Medical Arts District as a premiere wellness, health care treatment, medical education, and

29 research destination. The achievement of this development will 30 create local and regional jobs and greatly expand educational 31 opportunities in the area.
