

House Bill 1018 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating the Board of Commissioners of Emanuel County, approved  
2 August 18, 1919 (Ga. L. 1919, p. 646), as amended, particularly by an Act approved  
3 February 27, 2012 (Ga. L. 2012, p. 3735), so as to change the description of the  
4 commissioner districts; to provide for definitions and inclusions; to provide for continuation  
5 in office of current members; to provide for election and terms of office of subsequent  
6 members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Emanuel County, approved August 18, 1919  
10 (Ga. L. 1919, p. 646), as amended, particularly by an Act approved February 27, 2012 (Ga.  
11 L. 2012, p. 3735), is amended by revising subsections (b) and (d) of Section 1 as follows:

12 "(b) Those members of the Board of Commissioners of Emanuel County who are serving  
13 as such on the effective date of this Act and any person selected to fill a vacancy in any  
14 such office shall continue to serve as such members until the regular expiration of their  
15 respective terms of office and upon the election and qualification of their respective  
16 successors."

17 "(d)(1) For purposes of electing members of the board of commissioners, Emanuel  
18 County is divided into five single-member commissioner districts. The five  
19 commissioner districts shall be and correspond to those five numbered districts described  
20 in Appendix A attached to and made a part of this Act and further identified as 'User:  
21 Emanuel CC Plan Name: EmanuelCC-2022 Plan Type: Local'.

22 (2) For the purposes of such plan:

23 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
24 provided in the report of the Bureau of the Census for the United States decennial  
25 census of 2020 for the State of Georgia. The separate numeric designations in a district  
26 description which are underneath a VTD heading shall mean and describe individual  
27 blocks within a VTD as provided in the report of the Bureau of the Census for the  
28 United States decennial census of 2020 for the State of Georgia; and

29 (B) Except as otherwise provided in the description of any district, whenever the  
30 description of any district refers to a named city, it shall mean the geographical  
31 boundaries of that city as shown on the census maps for the United States decennial  
32 census of 2020 for the State of Georgia.

33 (3) Any part of Emanuel County which is not included in any district described in  
34 paragraph (1) of this subsection shall be included within that district contiguous to such  
35 part which contains the least population according to the United States decennial census  
36 of 2020 for the State of Georgia.

37 (4) Any part of Emanuel County which is described in paragraph (1) of this subsection  
38 as being included in a particular district shall nevertheless not be included within such  
39 district if such part is not contiguous to such district. Such noncontiguous part shall  
40 instead be included within that district contiguous to such part which contains the least  
41 population according to the United States decennial census of 2020 for the State of  
42 Georgia.

43 (5) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the  
44 effective date of this Act, shall continue to be designated as Commissioner Districts 1,  
45 2, 3, 4, and 5, respectively, but as newly described under this Act, and on and after the  
46 effective date of this Act, such members of the board serving from those former  
47 commissioner districts shall be deemed to be serving from and representing their  
48 respective districts as newly described under this Act."

49 **SECTION 2.**

50 Said Act is further amended by striking in its entirety the attachment thereto containing the  
51 descriptions of the five commissioner districts which is identified as 'Plan: emanuelcc-2012  
52 Plan Type: Local Administrator: Emanuel cc User: bak'.

53 **SECTION 3.**

54 The provisions of this Act necessary to conduct elections for the members of the board  
55 in 2022 shall become effective upon the approval of this Act by the Governor or upon its  
56 becoming law without such approval. The remaining provisions of this Act shall become  
57 effective on January 1, 2023.

58 **SECTION 4.**

59 All laws and parts of laws in conflict with this Act are repealed.
