A BILL TO BE ENTITLED AN ACT

To amend Chapter 5 of Title 30 of the Official Code of Georgia Annotated, relating to 1 protection of disabled adults and elder persons, so as to require the establishment of an Adult 2 3 Abuse, Neglect, and Exploitation Multidisciplinary Team in each judicial circuit; to provide 4 for an exception; to establish the Adult Abuse, Neglect, and Exploitation Multidisciplinary 5 Coordinator Program within the Prosecuting Attorneys' Council of the State of Georgia; to provide for a definition; to provide for duties and responsibilities of regional coordinators of 6 7 the program; to create an elder justice coalition for the State of Georgia for the purpose of 8 preventing disabled adult and elder person abuse, neglect, and exploitation; to provide for 9 membership composition; to provide for duties and responsibilities; to provide for 10 dissemination of information created by the coalition to the Georgia Peace Officer Standards 11 and Training Council; to provide for related matters; to repeal conflicting laws; and for other 12 purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

15 Chapter 5 of Title 30 of the Official Code of Georgia Annotated, relating to protection of

16 disabled adults and elder persons, is amended in Code Section 30-5-11, relating to

17 establishment of Adult Abuse, Neglect, and Exploitation Multidisciplinary Team,

- 18 membership, duties, creation of memorandum of understanding, confidentiality and
- 19 limitations on disclosures, and reporting and reviews, by revising subsection (a) and by
- 20 adding a new subsection to read as follows:
- 21 "(a) The district attorney of each judicial circuit may shall establish, or cause to be
- 22 established, an Adult Abuse, Neglect, and Exploitation Multidisciplinary Team for the
- purposes of:"
- 24 "(g) Notwithstanding subsection (a) of this Code section, no judicial circuit shall be
- required to establish an Adult Abuse, Neglect, and Exploitation Multidisciplinary Team
- 26 unless and until the Adult Abuse, Neglect, and Exploitation Multidisciplinary Coordinator
- 27 Program, as created in Code Section 30-5-12, is funded within the Prosecuting Attorneys'
- 28 Council of the State of Georgia to oversee and manage such team."

SECTION 2.

- 30 Said chapter is further amended by adding new Code sections to read as follows:
- 31 "30-5-12.
- 32 (a) For purposes of this Code section, the term 'regional coordinator' means an employee
- 33 <u>or contractor of the Prosecuting Attorneys' Council of the State of Georgia who is assigned</u>
- 34 to one or more judicial circuits, acts as agent and designee of such circuit or circuits, and
- 35 oversees and manages the circuit's or circuits' Adult Abuse, Neglect, and Exploitation
- 36 <u>Multidisciplinary Team meetings.</u>
- 37 (b) There is established within the Prosecuting Attorneys' Council of the State of Georgia
- 38 <u>the Adult Abuse, Neglect, and Exploitation Multidisciplinary Coordinator Program for the</u>
- 39 purpose of establishing a network of regional coordinators.
- 40 (c) Regional coordinators as defined in subsection (a) of this Code section shall have the
- 41 <u>following duties and responsibilities:</u>

42 (1) To schedule, coordinate, and follow up on all Adult Abuse, Neglect, and Exploitation

- 43 Multidisciplinary Team meetings and activity within their circuit; and
- 44 (2) To prepare and submit the report required by paragraph (1) of subsection (f) of Code
- 45 Section 30-5-11.
- 46 <u>30-5-13.</u>
- 47 (a) There shall be created an elder justice coalition for the State of Georgia.
- 48 (b) The elder justice coalition may conduct meetings at such places and at such times as
- 49 <u>it may deem necessary or convenient to enable it to exercise fully and effectively its</u>
- 50 powers, perform its duties, and accomplish the objectives and purposes of this Code
- 51 section. The elder justice coalition shall meet not less than twice each year.
- 52 (c) The leadership of the elder justice coalition shall be composed of a state-wide
- 53 coordinator, to be hired and housed at the Prosecuting Attorneys' Council of the State of
- 54 Georgia, and a chairperson to be elected by the membership of such coalition to serve one
- 55 calendar year. The state-wide coordinator, in consultation with the chairperson, shall have
- 56 <u>the authority and responsibility to call regular and special meetings of such coalition and</u>
- 57 <u>shall set agendas for such meetings.</u>
- 58 (d) The elder justice coalition shall be composed of the following members:
- 59 (1) A representative of the Division of Aging Services of the Department of Human
- 60 Services;
- 61 (2) A representative of the Georgia Bureau of Investigation's Crimes Against Disabled
- Adults and Elderly (CADE) Task Force or a representative from the Georgia Bureau of
- 63 <u>Investigation with experience in crimes against vulnerable adults;</u>
- 64 (3) A representative from the Prosecuting Attorneys' Council of the State of Georgia;
- 65 (4) A representative from the Criminal Justice Coordinating Council;
- 66 (5) A representative from the Georgia Bankers Association;
- 67 (6) A representative from the Alzheimer's Association, Georgia chapter;

- 68 (7) A representative from the Office of the State Long-Term Care Ombudsman;
- 69 (8) A representative from the Healthcare Facility Regulation Division of the Department
- of Community Health;
- 71 (9) A representative from the Department of Behavioral Health and Developmental
- 72 <u>Disabilities</u>;
- 73 (10) A representative from the Georgia Council on Aging;
- 74 (11) A medical professional with an active practice specializing in geriatrics;
- 75 (12) A coroner or medical examiner;
- 76 (13) A professional with expertise in Alzheimer's disease, dementia, or other
- 77 <u>degenerative brain disorder or cognitive impairment;</u>
- 78 (14) Georgia Secretary of State;
- 79 (15) Georgia Senior Living Association;
- 80 (16) Georgia Memory Net;
- 81 (17) A dementia specialist from Emory;
- 82 (18) Georgia Credit Union Association;
- 83 (19) Community Bankers Association;
- 84 (20) Georgia Health care Association; and
- 85 (21) Other such representatives as needed within the discretion of the coalition.
- 86 (d) The coalition shall appoint two law enforcement officers, as defined in Code Section
- 87 <u>35-1-7</u>, and two attorneys with prosecutorial experience in crimes against disabled adults
- 88 or elder persons pursuant to Article 8 of Chapter 5 of Title 16 or Code Sections 30-5-5,
- 89 <u>31-7-12.1, or 31-8-83.</u>
- 90 (e) The coalition shall be tasked with the duties to:
- 91 (1) Create a law enforcement protocol and guide and subsequent training for law
- 92 <u>enforcement officers when responding to instances of abuse of disabled adults or elder</u>
- 93 persons;

94 (2) Conduct training related to disability, Alzheimer's disease, dementia, and other 95 degenerative brain disorders or cognitive impairments, in conjunction with partner 96 organizations such as the Alzheimer's Association, Georgia Advocacy Office, Georgia 97 Council on Developmental Disabilities, Georgia Gerontology Society, and other similar 98 agencies and organizations, and training related to the appropriate response to victims living with such impairments; 99 100 (3) Partner with state agencies and state and local organizations to promote awareness, 101 outreach, and support for a holistic care perspective, to include, but not be limited to, 102 access to resources, facility staffing, and prevention of disabled adult and elder person 103 abuse, neglect, and exploitation; 104 (4) Provide case analysis and assistance, including, but not limited to, advising localities on investigating and prosecuting cases and safeguarding disabled adults or elder persons 105 106 who are victims of abuse, neglect, and exploitation; 107 (5) Provide support and assistance to local Adult Abuse, Neglect, and Exploitation 108 Multidisciplinary Teams; 109 (6) Develop strategies for providing holistic care and wraparound services for disabled 110 adults and elder persons who are victims of adult abuse, neglect, and exploitation in the 111 State of Georgia; and 112 (7) Provide a biannual report to the Governor and the General Assembly outlining areas of opportunity, success, and recommendations for preventing and responding to disabled 113 114 adult and elder person abuse, neglect, and exploitation in this state. (f) The guidelines and procedures listed in paragraphs (1) and (2) of subsection (e) of this 115 116 Code section shall be provided for use by law enforcement training centers monitored by the Georgia Peace Officer Standards and Training Council." 117
