A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to reconstitute the Washington County Board of Education, approved April
2 5, 1993 (Ga. L. 1993, p. 4652), as amended, particularly by an Act approved May 6, 2013
3 (Ga. L. 2013, p. 4153), so as to revise the districts for the election of members of the board
4 of education; to provide for definitions and inclusions; to provide for continuation in office
5 of current members; to provide for related matters; to provide for effective dates; to repeal
6 conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to reconstitute the Washington County Board of Education, approved April 5, 1993
10 (Ga. L. 1993, p. 4652), as amended, particularly by an Act approved May 6, 2013 (Ga. L.
11 2013, p. 4153), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) Those members of the Washington County Board of Education who are serving as such
14 on the effective date of this Act and any person selected to fill a vacancy in any such office
15 shall continue to serve as such members until the regular expiration of their respective

16 terms of office and upon the election and qualification of their respective successors. The
17 board shall consist of five members who, except for the chairperson, shall be elected from
18 the education districts described in this section. The chairperson shall be elected at large
19 as provided in Section 7 of this Act.

20 (b) Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act,
21 shall continue to be designated as Districts 1, 2, 3, and 4, respectively, but as newly
22 described under this Act, and on and after the effective date of this Act, such members of
23 the board serving from those former districts shall be deemed to be serving from and
24 representing their respective districts as newly described under this Act.

25 (c) For the purpose of electing members to the board of education other than the
26 chairperson, the Washington County School District shall be divided into four education
27 districts. Districts 1, 2, 3, and 4 shall be and correspond to those four numbered districts
28 described in Appendix A attached to and made a part of this Act and further identified as
29 'User: Washington Co. Plan Name: WashingtonCCSB-2022 Plan Type: Local'.

30 (d)(1) For the purposes of such plan:

31 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
32 provided in the report of the Bureau of the Census for the United States decennial
33 census of 2020 for the State of Georgia. The separate numeric designations in a district
34 description which are underneath a VTD heading shall mean and describe individual
35 Blocks within a VTD as provided in the report of the Bureau of the Census for the
36 United States decennial census for 2020 for the State of Georgia; and

37 (B) Except as otherwise provided in the description of any district, whenever the
38 description of any district refers to a named city, it shall mean the geographical
39 boundaries of that city as shown on the census maps for the United States decennial
40 census of 2020 for the State of Georgia.

41 (2) Any part of the Washington County School District which is not included in any
42 district described in subsection (c) of this section shall be included within that district

43 contiguous to such part which contains the least population according to the United States
44 decennial census of 2020 for the State of Georgia.

45 (3) Any part of the Washington County School District which is described in subsection
46 (c) of this section as being included in a particular district shall nevertheless not be
47 included within such district if such part is not contiguous to such district. Such
48 noncontiguous part shall instead be included within that district contiguous to such part
49 which contains the least population according to the United States decennial census of
50 2020 for the State of Georgia."

51 **SECTION 2.**

52 The provisions of this Act necessary to conduct elections for the members of the Washington
53 County Board of Education in 2022 shall become effective upon the approval of this Act by
54 the Governor or upon its becoming law without such approval. The remaining provisions
55 of this Act shall become effective on January 1, 2023.

56 **SECTION 3.**

57 All laws and parts of laws in conflict with this Act are repealed.
