

**SENATE SUBSTITUTE TO HB 1303****AS PASSED SENATE**

A BILL TO BE ENTITLED

AN ACT

1 To amend Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to  
2 special license plates promoting or supporting certain worthy agencies, funds, or nonprofit  
3 corporations with proceeds disbursed to the general fund and the agency, fund, or nonprofit  
4 corporation, so as to establish a specialty license plate honoring the Shepherd Center; to  
5 provide for disposition of funds to the Shepherd Center; to establish a specialty license plate  
6 supporting the advocacy and promotion of strict interpretation of the United States  
7 Constitution with a portion of funds collected to be disbursed to the Foundation for Moral  
8 Law, Inc.; to establish a specialty license plate honoring the Okefenokee Swamp; to provide  
9 for the disposition of funds to the Okefenokee Swamp Park; to establish a specialty license  
10 plate honoring alumni of Samford University; to provide for disposition of funds to the  
11 Samford University Alumni Association; to establish a specialty license plate honoring Delta  
12 Sigma Theta Sorority, Inc., and provide for the disposition of funds to the Delta Life  
13 Development Center; to amend Code Section 40-2-86.1 of the Official Code of Georgia  
14 Annotated, relating to special license plates promoting or supporting certain worthy agencies,  
15 funds, or nonprofit corporations and qualified motor vehicles or drivers with proceeds  
16 deposited into the general fund; to provide for conditions for the production of such license  
17 plates; to provide for discontinuing the manufacture of such license plates in certain  
18 instances; to provide for the disposition of funds to the general fund; to provide for related

19 matters; to provide for an effective date; to provide for compliance with constitutional  
20 requirements; to repeal conflicting laws; and for other purposes.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

22 **SECTION 1.**

23 Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to special license  
24 plates promoting or supporting certain worthy agencies, funds, or nonprofit corporations with  
25 proceeds disbursed to the general fund and the agency, fund, or nonprofit corporation, is  
26 amended in subsection (l) by adding new paragraphs to read as follows:

27 "(71) A special license plate honoring the Shepherd Center. The funds raised by the sale  
28 of this special license plate shall be disbursed to Shepherd Center, Inc.

29 (72) A special license plate supporting the advocacy and promotion of strict  
30 interpretation of the United States Constitution. The funds raised by the sale of this  
31 special license plate shall be disbursed to the Foundation for Moral Law, Inc.

32 (73) A special license plate honoring the Okefenokee Swamp and displaying the words  
33 'Explore the Okefenokee.' The funds raised by the sale of this special license plate shall  
34 be disbursed to the Okefenokee Swamp Park.

35 (74) A special license plate honoring alumni of Samford University. The funds raised  
36 by the sale of this special license plate shall be disbursed to the Samford University  
37 Alumni Association.

38 (75) A special license plate honoring Delta Sigma Theta Sorority, Inc. The funds raised  
39 by the sale of this special license plate shall be disbursed to the Delta Life Development  
40 Center."

41 **SECTION 2.**

42 This Act shall become effective on January 1, 2025.

**SECTION 3.**

44 In accordance with the requirements of Article III, Section IX, Paragraph VI(n) of the  
45 Constitution of the State of Georgia, this Act shall not become law unless it receives the  
46 requisite two-thirds' majority vote in both the Senate and the House of Representatives.

**SECTION 4.**

48 All laws and parts of laws in conflict with this Act are repealed.
