The Senate Committee on Judiciary offered the following substitute to HB 1528:

A BILL TO BE ENTITLED AN ACT

- 27 <u>(F) Purchase of equipment and technology for support in motor vehicle related crime</u>
- 28 prevention, reduction, and investigation;
- 29 (G) Provision of training to local law enforcement agencies and multi-jurisdiction task
- forces relative to motor vehicle related crime prevention, reduction, and investigation;

- 32 (H) Production of public awareness materials and programs relating to motor vehicle
- 33 <u>related crime prevention;</u>
- 34 (2) Promote state-wide planning and coordination of the investigation and prosecution
- of crimes relating to motor vehicle and motor vehicle parts theft;
- 36 (3) Provide support to local prosecutors handling motor vehicle and motor vehicle parts

- 38 (4) Provide support to multi-jurisdiction task forces established by local law enforcement

- 41 (b)(1) Any grant awarded pursuant to this Code section shall be upon recommendation

The ability to contribute 66 additional moneys or match funding for a program shall not be required as a condition 67 of receipt of a grant pursuant to this Code section. 68 (c) For the purposes of this Code section, the council may accept and use federal funds 69 granted by Congress or executive order, as well as gifts and donations from individuals, private organizations, or foundations. The acceptance and use of federal funds shall not 70

- 78 (a) There is established the Georgia Motor Vehicle Crime Prevention Advisory Board

- 82 (2) The state revenue commissioner or his or her designee from within the Department

97 (E) A consumer protection group. 98 (b) The Governor shall appoint those members listed in paragraphs (4) through (9) of 99 subsection (a) of this Code section. 100 (c) Members of the Georgia Motor Vehicle Crime Prevention Advisory Board shall serve 101 for terms of four years. The advisory board shall elect a chairperson from among its 102 membership and may elect such other officers and committees as it considers appropriate. In the event of death, resignation, disqualification, or removal for any reason of any 103 104 member of the advisory board, vacancies shall be filled in the same manner as the original appointment and successors shall serve for the unexpired term. Membership on the 105 106 advisory board shall not constitute public office, and no member shall be disqualified from 107 holding public office by reason of his or her membership on the advisory board. (d) Citizen members of the Georgia Motor Vehicle Crime Prevention Advisory Board shall 108 109 receive a daily expense allowance in the amount specified in subsection (b) of Code 110 Section 45-7-21, as well as the mileage or transportation allowance authorized for state 111 employees. Members of the advisory board who are state officials or state employees shall 112 receive no compensation for their services on the advisory board but shall be reimbursed 113 for expenses incurred in the performance of their duties as members of the advisory board 114 in the same manner as they are reimbursed for expenses in their capacities as state officials 115 or state employees. The funds necessary for the reimbursement of the expenses of state 116 officials and state employees shall come from funds appropriated or otherwise available 117 to their respective departments. 118 (e) The Georgia Motor Vehicle Crime Prevention Advisory Board shall solicit and review
