

House Bill 159

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a new charter for the City of Jesup, approved December 16, 1937  
2 (Ga. L. 1937-38 Ex. Sess., p. 1142), as amended, particularly by an Act approved  
3 April 30, 2013 (Ga. L. 2013, p. 3997), so as to reapportion the city board of commissioners  
4 election districts; to provide for definitions and inclusions; to provide for continuation in  
5 office of current members; to provide for an effective date; to provide for related matters; to  
6 repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating a new charter for the City of Jesup, approved December 16, 1937 (Ga. L.  
10 1937-38 Ex. Sess., p. 1142), as amended, particularly by an Act approved April 30, 2013  
11 (Ga. L. 2013, p. 3997), is amended by revising subsections (b) and (c) of Section 4 as  
12 follows:

13 "(b) For the purpose of electing members of the board of commissioners, the City of Jesup  
14 shall be divided into six election districts. Those election districts shall be and correspond  
15 to those six numbered districts described in Appendix A attached to and made a part of this  
16 Act and further identified as 'User: Jesup Plan Name: JesupCity-2023 Plan Type: Local'.

17 (c)(1) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
19 provided in the report of the Bureau of the Census for the United States decennial  
20 census of 2020 for the State of Georgia. The separate numeric designations in an  
21 election district description which are underneath a VTD heading shall mean and  
22 describe individual Blocks within a VTD as provided in the report of the Bureau of the  
23 Census for the United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any election district, whenever  
25 the description of any election district refers to a named city, it shall mean the  
26 geographical boundaries of that city as shown on the census maps for the United States  
27 decennial census of 2020 for the State of Georgia.

28 (2) Any part of the City of Jesup which is not included in any election district described  
29 in subsection (b) of this section shall be included within that election district contiguous  
30 to such part which contains the least population according to the United States decennial  
31 census of 2020 for the State of Georgia.

32 (3) Any part of the City of Jesup which is described in subsection (b) of this section as  
33 being included in a particular election district shall nevertheless not be included within  
34 such election district if such part is not contiguous to such election district. Such  
35 noncontiguous part shall instead be included within that election district contiguous to  
36 such part which contains the least population according to the United States decennial  
37 census of 2020 for the State of Georgia."

38 **SECTION 2.**

39 (a) Those members of the Board of Commissioners of the City of Jesup who are serving as  
40 such on the effective date of this Act and any person selected to fill a vacancy in any such  
41 office shall continue to serve as such members until the regular expiration of their respective  
42 terms of office and upon the election and qualification of their respective successors.

43 (b) Election Districts 1, 2, 3, 4, 5, and 6 as they exist immediately prior to the effective date  
44 of this Act shall continue to be designated as Election Districts 1, 2, 3, 4, 5, and 6,  
45 respectively, but as newly described under this Act, and on and after the effective date of this  
46 Act, such members of the board of commissioners serving from those former election  
47 districts shall be deemed to be serving from and representing their respective election  
48 districts as newly described under this Act.

49 **SECTION 3.**

50 This Act shall become effective on July 1, 2023.

51 **SECTION 4.**

52 All laws and parts of laws in conflict with this Act are repealed.
