## A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 3 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia
- 2 Annotated, relating to Georgia Student Finance Authority, so as to provide for inclusive
- 3 postsecondary education (IPSE) grants; to provide for definitions; to provide for student
- 4 eligibility; to provide for funding; to provide for policies, procedures, rules, and regulations,
- 5 including requirements for program authorization; to provide for related matters; to repeal
- 6 conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

- 9 Part 3 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia Annotated,
- 10 relating to Georgia Student Finance Authority, is amended by adding a new subpart to read
- 11 as follows:

- 14 (a) As used in this subpart, the term:

15 (1) 'Authorized IPSE program' means an inclusive postsecondary education (IPSE)

- program for students with intellectual disabilities that has been authorized by the Georgia
- 17 <u>Student Finance Authority for the purposes of awarding IPSE grants to eligible students.</u>
- 18 (2) 'IPSE grant' means an inclusive postsecondary education (IPSE) grant for education
- 19 <u>awarded in accordance with this subpart.</u>
- 20 (3) 'Qualified postsecondary institution' means a unit of the University System of
- 21 Georgia or a unit of the Technical College System of Georgia that offers an authorized
- 22 <u>IPSE program.</u>
- 23 (b) To be eligible for an IPSE grant, a student shall:
- 24 (1) Meet the requirements provided for in paragraph (1) of subsection (a) and
- subsection (b) of Code Section 20-3-519.1; and
- 26 (2) Meet enrollment standards by being admitted and enrolled in an authorized IPSE
- 27 <u>program at a qualified postsecondary institution.</u>
- 28 (c) Subject to the amount of funds appropriated by the General Assembly and other
- 29 available funding, eligible students enrolled in an authorized IPSE program on or before
- July 1, 2028, shall receive an IPSE grant in an amount equal to the current academic year
- 31 standard undergraduate tuition amount at each such student's respective qualified
- 32 postsecondary institution.
- 33 (d) The Georgia Student Finance Authority, in collaboration with the University System

40	(2) Require that a participating student be enrolled in courses with non-disabled peers
41	for at least 50 percent of the courses in which such participating student is enrolled as part

43	(3) Provide individual supports and services for the academic and social inclusion of
44	students with intellectual disabilities in academic courses, extracurricular activities, and
45	other aspects of the qualified postsecondary institution's regular postsecondary program;

59 **SECTION 2.** 

All laws and parts of laws in conflict with this Act are repealed. 60
