

Senators Hill of the 6th and Hufstetler of the 52nd offered the following amendment:

1 *Amend HB 213 (LC 29 7432S) by replacing lines 20 through 22 with the*
 2 *following:*

3 Said part is further amended by revising the introductory language to paragraph (1) of
 4 subsection (a), paragraph (2) of subsection (a), subsection (b), and the introductory language
 5 to subsections (c), (d), (e), and (f) of Code Section 16-13-31, relating to trafficking in
 6 cocaine, illegal drugs, marijuana, or methamphetamine, as follows:

7 "(a)(1) ~~Any~~ Except as authorized by this article, any person who sells, manufactures,
 8 delivers, or brings into this state or who is in possession of 28 grams or more of cocaine
 9 or of any mixture with a purity of 10 percent or more of cocaine, as described in Schedule
 10 II, in violation of this article commits the felony offense of trafficking in cocaine and,
 11 upon conviction thereof, shall be punished as follows:"

12 "(2) ~~Any~~ Except as authorized by this article, any person who sells, manufactures,
 13 delivers, or brings into this state or who is in possession of any mixture with a purity of
 14 less than 10 percent of cocaine, as described in Schedule II, in violation of this article
 15 commits the felony offense of trafficking in cocaine if the total weight of the mixture
 16 multiplied by the percentage of cocaine contained in the mixture exceeds any of the
 17 quantities of cocaine specified in paragraph (1) of this subsection. Upon conviction
 18 thereof, such person shall be punished as provided in paragraph (1) of this subsection,
 19 depending upon the quantity of cocaine such person is charged with selling,
 20 manufacturing, delivering, or bringing into this state or possessing.

21 (b) ~~Any~~ Except as authorized by this article, any person who sells, manufactures, delivers,
 22 brings into this state, or has possession

25 "(c) ~~Any~~ Except as authorized by this article, any person who sells, manufactures, grows,
 26 delivers, brings into this state, or has possession of a quantity of marijuana exceeding ten
 27 pounds commits the offense of trafficking in marijuana and, upon conviction thereof, shall
 28 be punished as follows:"

29 "(d) ~~Any~~ Except as authorized by this article, any person who sells, manufactures, delivers,
 30 or brings into this state 200 grams or more of methaqualone or of any mixture containing
 31 methaqualone, as described in paragraph (6) of Code Section 16-13-25, in violation of this

32 article commits the felony offense of trafficking in methaqualone and, upon conviction
33 thereof, shall be punished as follows:"

34 "(e) ~~Any~~ Except as authorized by this article, any person who sells, delivers, or brings into
35 this state or has possession of 28 grams or more of methamphetamine, amphetamine, or
36 any mixture containing either methamphetamine or amphetamine, as described in Schedule
37 II, in violation of this article commits the felony offense of trafficking in methamphetamine
38 or amphetamine and, upon conviction thereof, shall be punished as follows:"

39 "(f) ~~Any~~ Except as authorized by this article, any person who manufactures
40 methamphetamine, amphetamine, or any mixture containing either methamphetamine or
41 amphetamine, as described in Schedule II, in violation of this article commits the felony
42 offense of trafficking methamphetamine or amphetamine and, upon conviction thereof,
43 shall be punished as follows:"
