## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 2 of Title 12 of the Official Code of Georgia Annotated,
- 2 relating to general provisions relative to the Department of Natural Resources, so as to
- 3 extend the date by which rules and regulations prescribed by the Board of Natural Resources
- 4 must be in effect for purposes of establishing criminal violations of said rules and
- 5 regulations; to amend Part 7 of Article 7 of Chapter 3 of Title 12 of the Official Code of
- 6 Georgia Annotated, relating to the Sapelo Island Heritage Authority, so as to amend the
- 7 composition and chairmanship of the Sapelo Island Heritage Authority; to provide for related
- 8 matters; to repeal conflicting laws; and for other purposes.

## 9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 11 Article 1 of Chapter 2 of Title 12 of the Official Code of Georgia Annotated, relating to
- 12 general provisions relative to the Department of Natural Resources, is amended in Code
- 13 Section 12-2-2, relating to the Environmental Protection Division, Environmental Advisory
- 14 Council, duties of council and its members and director, appeal procedures generally, permit
- 15 applications, and inspections, by revising paragraph (5) of subsection (c) as follows:

16 "(5) Notwithstanding any other law to the contrary, for purposes of establishing criminal

- violations of the standards, rules, and regulations promulgated by the Board of Natural
- 18 Resources as provided in this title, the term 'standards, rules, and regulations' shall mean
- those standards, rules, and regulations of the Board of Natural Resources in force and
- 20 effect on January 1, <del>2022</del> <u>2023</u>."

## 21 SECTION 2.

- 22 Part 7 of Article 7 of Chapter 3 of Title 12 of the Official Code of Georgia Annotated,
- 23 relating to the Sapelo Island Heritage Authority, is amended in Code Section 12-3-444,
- 24 relating to membership, officers, compensation, quorum, and meetings by revising
- 25 subsections (a) and (b) as follows:
- 26 "(a) The authority shall be composed of five members as follows:
- 27 (1) The Governor, or his or her designee;
- 28 (2) The commissioner of natural resources;
- 29 (3) The executive director of the State Properties Commission; and
- 30 (4) A resident Two resident descendants of the community of Hog Hammock described
- in paragraph (5) of subsection (a) of Code Section 12-3-441 to be appointed by the
- Governor for a term of four years; and
- 33 (5) The Commissioner of Human Relations in the office of the Governor; provided,
- 34 however, that if a vacancy exists in such office for longer than 60 consecutive days, the
- 35 Governor shall appoint instead a second resident of the community of Hog Hammock for
- 36 a term of four years, after which the Commissioner of Human Relations, if such office
- 37 is then occupied, shall become a member.
- 38 Vacancies in the appointed positions shall be filled for the remainder of the term by
- 39 appointment of the Governor.

40 (b) The Governor commissioner of natural resources shall be the chairperson of the

- 41 authority, the commissioner of natural resources Governor shall be its vice chairperson, and
- 42 the executive director of the State Properties Commission shall be its secretary-treasurer."
- 43 **SECTION 3.**
- 44 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 45 without such approval.
- 46 **SECTION 4.**
- 47 All laws and parts of laws in conflict with this Act are repealed.
