## A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 15-11-2 and Title 19 of the Official Code of Georgia Annotated,
- 2 relating to definitions for the Juvenile Code and domestic relations, respectively, so as to
- 3 provide that causing a child to be conceived as a result of violating certain prohibitions
- 4 relating to certain offenses is an additional ground for terminating parental rights; to revise
- 5 definitions; to provide that causing a child to be conceived as a result of violating certain
- 6 prohibitions relating to certain offenses is an additional ground for losing parental rights and
- 7 is relevant in certain adoption proceedings; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 11 Code Section 15-11-2 of the Official Code of Georgia Annotated, relating to definitions for
- the Juvenile Code, is amended by revising paragraph (5) as follows:
- 13 "(5) 'Aggravated circumstances' means the parent has:
- 14 (A) Abandoned a child;
- 15 (B) Aided or abetted, attempted, conspired, or solicited to commit murder or voluntary
- manslaughter of another child of such parent;
- 17 (C) Subjected a child or his or her sibling to torture, chronic abuse, sexual abuse, or
- sexual exploitation;
- 19 (D) Committed the murder or voluntary manslaughter of his or her child's other parent
- or has been convicted of aiding or abetting, attempting, conspiring, or soliciting the
- 21 murder or voluntary manslaughter of his or her child's other parent;
- (E) Committed the murder or voluntary manslaughter of another child of such parent;

- 24 (F) Committed an assault that resulted in serious bodily injury to his or her child or
- another child of such parent; or

26	(G) Caused the child to be conceived as a result of rape in violation of Code Section

29	SECTION 2.

- 30 Title 19 of the Official Code of Georgia Annotated, relating to domestic relations, is
- 31 amended by revising subsection (b) of Code Section 19-7-1, relating to with whom parental
- 32 power lies, as follows:
- 33 "(b) Parental power shall be lost by:
- 34 (1) Voluntary contract releasing the right to a third person;
- 35 (2) Consent to the adoption of the child by a third person;
- 36 (3) Failure to provide necessaries for the child or abandonment of the child;
- 37 (4) Consent to the child's receiving the proceeds of his <u>or her</u> own labor, which <del>consent</del>
- shall be revocable at any time;
- 39 (5) Consent to the marriage of the child, who thus assumes inconsistent responsibilities;
- 40 (6) Cruel treatment of the child;
- 41 (7) A superior court order terminating parental rights in an adoption proceeding in
- 42 accordance with Chapter 8 of this title; or
- 43 (8) Causing the child to be conceived as a result of rape in violation of Code Section
- 44 <u>16-6-1, incest in violation of Code Section 16-6-22, or trafficking for sexual servitude in</u>
- 45 <u>violation of Code Section 16-5-46; or</u>
- 46 (8)(9) A superior court order terminating parental rights of the legal father or the
- biological father who is not the legal father of the child in a petition for legitimation, a
- petition to establish paternity, a divorce proceeding, or a custody proceeding pursuant to
- 49 this chapter or Chapter 5, 8, or 9 of this title, provided that such termination is in the best
- interest of such child; and provided, further, that this paragraph shall not apply to such
- termination when a child has been adopted or is conceived by artificial insemination as
- set forth in Code Section 19-7-21 or when an embryo is adopted as set forth in Article 2
- of Chapter 8 of this title."

## 54 SECTION 3.

- 55 Said title is further amended by revising subsection (a) of Code Section 19-8-10, relating to
- 56 when the surrender or termination of parental rights is not required in the context of adoption,
- 57 as follows:
- 58 "(a) Surrender or termination of rights of a parent pursuant to subsection (a) of Code
- 59 Section 19-8-4, 19-8-5, 19-8-6, or 19-8-7 shall not be required as a prerequisite to the filing

of a petition for adoption of a child of that parent pursuant to Code Section 19-8-13 where

- 61 <u>when</u> the court determines by clear and convincing evidence that the:
- 62 (1) Child has been abandoned by that parent;
- 63 (2) Parent cannot be found after a diligent search has been made;
- 64 (3) Parent is insane or otherwise incapacitated from surrendering such rights; or
- 65 (4) Parent caused the child to be conceived as a result of rape in violation of Code
- Section 16-6-1, incest in violation of Code Section 16-6-22, or trafficking for sexual
- 67 <u>servitude in violation of Code Section 16-5-46; or</u>
- 68  $\frac{(4)(5)}{(5)}$  Parent has failed to exercise proper parental care or control due to misconduct or
- 69 inability, as set out in paragraph (3), (4), or (5) of subsection (a) of Code Section
- 70 15-11-310,
- and the court is of the opinion that the adoption is in the best interests of that child, after
- 72 considering the physical, mental, emotional, and moral condition and needs of the child
- who is the subject of the proceeding, including the need for a secure and stable home."

74 SECTION 4.

- 75 Said title is further amended by revising paragraph (3) of subsection (a) of Code Section
- 76 19-8-11, relating to petitioning the superior court to terminate parental rights, as follows:
- 77 "(3) Parental rights may be terminated pursuant to paragraph (1) or (2) of this subsection
- 78 where when the court determines by clear and convincing evidence that the:
- 79 (A) Child has been abandoned by that parent;
- 80 (B) Parent of the child cannot be found after a diligent search has been made;
- 81 (C) Parent is insane or otherwise incapacitated from surrendering such rights; or
- 82 (D) Parent caused the child to be conceived as a result of rape in violation of Code
- 83 Section 16-6-1, incest in violation of Code Section 16-6-22, or trafficking for sexual
- servitude in violation of Code Section 16-5-46; or
- 85 (D)(E) Parent has failed to exercise proper parental care or control due to misconduct
- or inability, as set out in paragraph (3), (4), or (5) of subsection (a) of Code Section
- 87 15-11-310,
- and the court shall set the matter down to be heard in chambers not less than 30 and not
- more than 60 days following the receipt by such remaining parent of the notice under
- subsection (b) of this Code section and shall enter an order terminating such parental
- 91 rights if it so finds and if it is of the opinion that adoption is in the best interests of the
- child, after considering the physical, mental, emotional, and moral condition and needs
- of the child who is the subject of the proceeding, including the need for a secure and
- 94 stable home."

## 95 **SECTION 5.**

All laws and parts of laws in conflict with this Act are repealed.
