A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the board of commissioners of Gwinnett County, approved
- 2 January 31, 1968 (Ga. L. 1968, p. 2003), as amended, particularly by an Act approved
- 3 April 1, 1994 (Ga. L. 1994, p. 4497), and by an Act approved September 21, 2011
- 4 (Ga. L. 2011 Ex. Sess., p. 296), so as to revise the commissioner district boundaries; to
- 5 define certain terms; to repeal a superseded description of commissioner districts; to provide
- 6 for continuation in office; to provide effective dates; to repeal conflicting laws; and for other
- 7 purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 An Act creating the board of commissioners of Gwinnett County, approved January 31, 1968
- 11 (Ga. L. 1968, p. 2003), as amended, particularly by an Act approved April 1, 1994 (Ga.
- 12 L. 1994, p. 4497), and by an Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess.,
- p. 296), is amended by revising subsections (b), (c), and (d) of Section 3 as follows:
- 14 "(b) The four commissioner districts shall be and correspond to those four numbered
- districts described in Appendix A attached to and made a part of this Act and further
- identified as 'User: Gwinnett CC Plan Name: Gwinnett CC-2022 Plan Type: Local'.

- (c)(1) For the purposes of such plan:
- 18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 24 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 28 (2) Any part of Gwinnett County which is not included in any district described in
- subsection (b) of this section shall be included within that district contiguous to such part
- which contains the least population according to the United States decennial census
- of 2020 for the State of Georgia.
- 32 (3) Any part of Gwinnett County which is described in subsection (b) of this section as
- being included in a particular district shall nevertheless not be included within such
- district if such part is not contiguous to such district. Such noncontiguous part shall
- instead be included within that district contiguous to such part which contains the least
- population according to the United States decennial census of 2020 for the State of
- 37 Georgia.
- 38 (d) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
- date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
- respectively, but as newly described under subsection (b) of this section, and on and after
- 41 the date this Act becomes effective, such members of the board serving from those former
- 42 commissioner districts shall be deemed to be serving from and representing their respective
- districts as newly described under subsection (b) of this section. Members of the board

shall serve for the terms of office provided in this section and until their respective

45 successors are elected and qualified."

46 SECTION 2.

- 47 Said Act is further amended by striking in its entirety the attachment thereto containing the
- 48 descriptions of the four commissioner districts which is identified as "Plan:
- 49 gwinnettcc-2011re2 Plan Type: Local User: bak".

SECTION 3.

51 Said Act is further amended by repealing subsection (b) of Section 13.

52 SECTION 4.

- 53 Those members of the board of commissioners of Gwinnett County who are serving as such
- on the effective date of this Act and any person selected to fill a vacancy in any such office
- shall continue to serve as such members until the regular expiration of their respective terms
- of office and upon the election and qualification of their respective successors.

57 **SECTION 5.**

- 58 The provisions of this Act relating to and necessary for the regular election in 2022 of
- 59 members of the board of commissioners of Gwinnett County shall become effective upon its
- approval by the Governor or upon its becoming law without such approval; and this Act shall
- otherwise become effective on January 1, 2023.

62 SECTION 6.

All laws and parts of laws in conflict with this Act are repealed.
