A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Board of Commissioners of Crisp County, approved
2 August 6, 1908 (Ga. L. 1908, p. 295), as amended, particularly by an Act approved
3 April 24, 2013 (Ga. L. 2013, p. 3580), so as to change the descriptions of commissioner
4 districts and posts for the election of members of the board of commissioners; to provide for
5 definitions and inclusions; to provide for continuation in office of current members; to
6 provide for effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Crisp County, approved August 6, 1908 (Ga.
10 L. 1908, p. 295), as amended, particularly by an Act approved April 24, 2013 (Ga. L. 2013,
11 p. 3580), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) For purposes of electing members of the Board of Commissioners of Crisp County,
14 Crisp County is divided into two commissioner districts. Each of the two commissioner
15 districts is divided into posts. Commissioner District 1 shall be divided into two posts,

16 designated as Commissioner District 1 - Post 1 and Commissioner District 1 - Post 2.
17 Commissioner District 2 shall be divided into three posts, designated as Commissioner
18 District 2 - Post 1, Commissioner District 2 - Post 2, and Commissioner District 2 - Post 3.
19 The such districts and posts shall be and correspond to those numbered districts and posts
20 described in Appendix A attached to and made a part of this Act and further identified as
21 'User: Crisp CC Plan Name: crispcc-2022 Plan Type: Local'.

22 (b)(1) For the purposes of such plan:

23 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
24 provided in the report of the Bureau of the Census for the United States decennial
25 census of 2020 for the State of Georgia. The separate numeric designations in a district
26 description which are underneath a VTD heading shall mean and describe individual
27 Blocks within a VTD as provided in the report of the Bureau of the Census for the
28 United States decennial census of 2020 for the State of Georgia; and

29 (B) Except as otherwise provided in the description of any district, whenever the
30 description of any district refers to a named city, it shall mean the geographical
31 boundaries of that city as shown on the census maps for the United States decennial
32 census of 2020 for the State of Georgia.

33 (2) Any part of Crisp County which is not included in any district described in
34 subsection (a) of this section shall be included within that district contiguous to such part
35 which contains the least population according to the United States decennial census
36 of 2020 for the State of Georgia.

37 (3) Any part of Crisp County which is described in subsection (a) of this section as being
38 included in a particular district shall nevertheless not be included within such district if
39 such part is not contiguous to such district. Such noncontiguous part shall instead be
40 included within that district contiguous to such part which contains the least population
41 according to the United States decennial census of 2020 for the State of Georgia."

SECTION 2.

43 (a) Those members of the Board of Commissioners of Crisp County who are serving as such
44 on the effective date of this Act and any person selected to fill a vacancy in any such office
45 shall continue to serve as such members until the regular expiration of their respective terms
46 of office and upon the election and qualification of their respective successors.

47 (b) Commissioner District 1 - Post 1, Commissioner District 1 - Post 2, Commissioner
48 District 2 - Post 1, Commissioner District 2 - Post 2, and Commissioner District 2 - Post 3,
49 shall continue to be designated as Commissioner District 1 - Post 1, Commissioner
50 District 1 - Post 2, Commissioner District 2 - Post 1, Commissioner District 2 - Post 2, and
51 Commissioner District 2 - Post 3, respectively, but as newly described under this Act, and
52 on and after the effective date of this Act, such members of the board serving from those
53 former commissioner districts shall be deemed to be serving from and representing their
54 respective districts as newly described under this Act.

55

SECTION 3.

56 The provisions of this Act necessary to conduct elections for the members of the Board of
57 Commissioners of Crisp County in 2022 shall become effective upon the approval of this Act
58 by the Governor or upon its becoming law without such approval. The remaining provisions
59 of this Act shall become effective on January 1, 2023.

SECTION 4.

61 All laws and parts of laws in conflict with this Act are repealed.
