A RESOLUTION

1 Recognizing February 3, 2016, as Albany-Dougherty County Day at the state capitol and
2 commending the Albany Area Chamber of Commerce; and for other purposes.

3 WHEREAS, the Albany Area Chamber of Commerce has served the interests of the Albany
4 Area business community with distinction for 106 years; and

5 WHEREAS, the Albany Area Chamber of Commerce combines the efforts of business and
6 governmental leaders and professional individuals to ensure a business climate conducive
7 to economic growth; to drive collaboration between governmental agencies, educational
8 institutions, and the business community; to support initiatives that facilitate opportunities
9 for job creation and business investment; to market Albany as an ideal tourism destination;
10 and to improve the quality of life for Albany Area citizens; and

11 WHEREAS, it ranks among the top tenth percentile of all chambers of commerce in the
12 country, as accredited by the United States Chamber of Commerce; and

13 WHEREAS, Albany-Dougherty County is known for its tourist attractions and outdoor
14 recreational opportunities; natural resources; educational institutions; Marine Corps Logistics
15 Base Albany; and global industries, including Procter & Gamble, MillerCoors, Mars
16 Chocolate North America, Pfizer, and Coats & Clark; and

17 WHEREAS, the Albany Area Chamber of Commerce manages and directs the Albany
18 Convention and Visitors Bureau, which is recognized as one of the most successful visitor
19 centers in the state, with an annual tourism related economic impact of \$221 million; whose
20 executive director received the 2015 Larry Allen Tourism Award; which has received the
21 2015 Reader's Choice Award for professionalism, customer service, and quality facilities by
22 *Convention South* magazine; and which is fully certified as a Gold Destination Marketing
23 Organization by the Georgia Convention and Visitors Bureau; and

24 WHEREAS, it is one of the largest chambers in the State of Georgia, serving nearly 1,000
25 members and representing the private, public, education, and nonprofit sectors and
26 manufacturing, health care, distribution and logistics, defense, finance, agriculture, and retail
27 markets; and

28 WHEREAS, it is abundantly fitting and proper that the 106th anniversary of the Albany Area
29 Chamber of Commerce and its accomplishments in supporting and leading the Albany Area
30 be appropriately recognized.

31 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
32 the members of this body recognize February 3, 2016, as Albany-Dougherty County Day at
33 the state capitol and congratulate the Albany Area Chamber of Commerce on 106 years of
34 excellence serving the economic hub of Southwest Georgia.
