- 5 Houston County and as one of 159 members of the Georgia Sheriffs' Association since
- 6 January 1, 1973; and
- 7 WHEREAS, throughout his career as Sheriff of Houston County, Sheriff Talton has been an
- 8 active member of the Board of Directors of the Georgia Sheriffs' Youth Homes which has
- 9 provided safe and wholesome homes for many thousands of Georgia's abused, abandoned,
- and neglected children since its beginning in 1959; and

- 12 continued participation as a member of this important governing board and for his local
- 13 fund-raising efforts in which he and his many supporters in the Houston County area have
- 14 raised nearly a quarter of a million dollars for many deserving children over the past few

- 16 WHEREAS, he is a recipient of the Liberty Bell Award, which is given by bar associations
- 17 across the United States to recognize special people in their communities; and
- 18 WHEREAS, a native of Bonaire, Georgia, Sheriff Talton has served 29 years as Sheriff of

- 20 WHEREAS, while serving his community as a law enforcement officer, he has also

- 26 WHEREAS, Sheriff Talton is a member of many civic organizations and has received an
- abundance of awards for his civic work over the past 35 years; and
- 28 WHEREAS, he is member of the Georgia Sheriffs' Association and the National Sheriffs'
- 29 Association, and his pet project is serving on the board of the Georgia Sheriffs' Boys Ranch
- 30 in Hahira; and
- 31 WHEREAS, Sheriff Talton has been honored as Georgia Sheriff of the Year and has received
- 32 the Warner Robins/Houston County Chamber of Commerce Good Government Service
- 33 Award; and
- 34 WHEREAS, he serves as a board member of the State of Georgia Department of Corrections
- and is chairman of the board of Security Bank in Houston County; and
- 36 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 37 remarkable and distinguished Georgian be appropriately recognized.
