### A RESOLUTION

- 2 WHEREAS, Hilda Abbott is the visionary founder and CEO of RudHil Companies, RudHil  
3 Commercial, RudHil Cares, and RudHil Development; and
- 4 WHEREAS, she is not only a seasoned real estate professional with over two decades of  
5 experience but also a compassionate leader who has initiated transformative programs to  
6 empower individuals and communities; and
- 7 WHEREAS, her extensive career encompasses various sectors in the real estate industry,  
8 including property management, investments, development, and commercial, and residential  
9 properties; and
- 10 WHEREAS, a proud Latina, she possesses an innate ability to discern the evolving landscape
