- 1 Honoring the life and memory of Mr. Asa Charles Daniels, Jr., and dedicating an interchange
- 2 in his memory; and for other purposes.
- 3 WHEREAS, the State of Georgia continues to mourn the loss of one of its most distinguished
- 4 citizens with the passing of Mr. Asa Charles Daniels, Jr., on April 7, 2014; and
- 5 WHEREAS, Mr. Daniels served as a guardian of this nation's freedom and liberty with the
- 6 United States Maritime Services, valiantly and courageously protecting his fellow
- 7 Americans; and
- 8 WHEREAS, after returning home from the war, he was given the opportunity to purchase
- 9 Pinehurst Equipment Company, an International Harvester farm implement dealership, which
- 10 was the world's largest manufacturer of farm equipment; and
- 11 WHEREAS, after a lucrative sale of Pinehurst Equipment Company, Mr. Daniels sold life
- insurance to local residents and became a top-producing life insurance salesman; and
- 13 WHEREAS, Mr. Daniels served as a Dooly County commissioner for 26 years, with eight
- 14 of those as chairperson; and
- 15 WHEREAS, he served his community in various capacities, including Dooly Medical Center
- 16 Hospital Authority chairperson, Middle Georgia Technical College board member, and
- 17 Dooly-Crisp Empowerment Zone board member; and
- 18 WHEREAS, his leadership and vision were instrumental on the Small Business Council of
- 19 Georgia for four years under Governor Joe Frank Harris and with the formation of the Dooly
- 20 County Economic Council; and

21 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern

- 22 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his
- 23 family and friends were admired by others; and
- 24 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 25 Georgian be recognized appropriately by dedicating an interchange in his memory.
- 26 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 27 ASSEMBLY OF GEORGIA that the interchange at I-75 and Pinehurst-Hawkinsville
- 28 Road/Exit 117 in Dooly County is dedicated as the Asa Daniels, Jr., Interchange.
- 29 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 30 directed to erect and maintain appropriate signs dedicating the Asa Daniels, Jr., Interchange.
- 31 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 32 and directed to make appropriate copies of this resolution available for distribution to the
- 33 family of Mr. Asa Charles Daniels, Jr., and to the Department of Transportation.
