- 19 Councilwoman Pittman, as Mayor Pro Tempore, was vaulted to the Office of Mayor where
- 20 she ushered in comfort and stability during a tumultuous time; and
- 21 WHEREAS, later that year, Acting Mayor Pittman decisively won a three-way race to
- become the City of Doraville's first female Mayor; and

- 25 improvements, and the building the economic development infrastructure necessary to foster
- 26 the unprecedented new urbanist revival of the former GM site now known as "Assembly";

- 29 helped establish Peachtree Charter Middle School and she has served on the DeKalb Board
- 30 of Education Advisory Board, and she continues to support public education from early
- 31 childhood development to lifelong learning for all; and
- 32 WHEREAS, Mayor Pittman, a devoted wife of a Marine and mother of four, continues to
- 33 provide exemplary leadership and commitment to Doraville as it continues serve as a catalyst
- 34 for state and regional growth.
