A BILL TO BE ENTITLED AN ACT

To amend Code Section 20-3-519.2 of the Official Code of Georgia Annotated, relating to eligibility requirements for a HOPE scholarship, so as to establish a procedure for students with a disability as defined by the Americans with Disabilities Act to apply for a waiver from certain HOPE scholarship and grant eligibility requirements; to provide for responsibilities of the Georgia Student Finance Commission; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

9 Code Section 20-3-519.2 of the Official Code of Georgia Annotated, relating to eligibility

10 requirements for a HOPE scholarship, is amended by revising subsection (d) as follows:

11 "(d) A student may receive the HOPE scholarship until the first of these events:

12 (1) The student has earned a baccalaureate or first professional degree;

13 (2) The student has attempted at any postsecondary institution a total of 190 quarterhours or 127 semester hours; or

- 15 (3) For those students receiving a HOPE scholarship for the first time between July 1,
- 16 2011, and June 30, 2019, seven years from a student's graduation from high school or the

17 equivalent thereof as determined by the Georgia Student Finance Commission in its rules 18 and regulations; provided, however, that for a student who serves in the military during 19 such seven-year period, any such active duty military service shall not count against the 20 seven-year period nor constitute a failure to be enrolled. For those students receiving a HOPE scholarship for the first time on or after July 1, 2019, ten years from a student's 21 graduation from high school or the equivalent thereof as determined by the Georgia 22 23 Student Finance Commission in its rules and regulations; provided, however, that for a 24 student who serves in the military during such ten-year period, any such active duty 25 military service shall not count against the ten-year period nor constitute a failure to be 26 enrolled. Any full-time or part-time student receiving a HOPE scholarship and enrolled 27 in an eligible postsecondary institution after June 30, 2019, shall remain eligible for a HOPE scholarship pursuant to this paragraph, provided that such student meets all other 28 29 eligibility requirements, including, but not limited to, those set forth in paragraphs (1) and 30 (2) of this subsection. Students with a disability, as defined in the federal Americans with 31 Disabilities Act, 42 U.S.C. Section 12102, which prevents or substantially inhibits 32 full-time academic study, may apply to the Georgia Student Finance Commission for a 33 limited waiver from the applicable year limit set forth in this paragraph and request 34 additional time to complete the first to occur of the events set forth in paragraphs (1) and 35 (2) of this subsection. Such application for a limited waiver shall be considered and 36 determined by the Georgia Student Finance Commission in accordance with its rules and 37 regulations."

SECTION 2.
