## AS PASSED SENATE

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 20 of the Official Code of Georgia Annotated, relating to education, so as to
- 2 establish the Georgia Council on Literacy; to provide for definitions; to provide for members
- 3 and officers; to provide for meetings, agendas, quorum, and compensation; to provide for the
- 4 council's duties and powers; to provide for consultation with subject matter experts; to
- 5 provide for automatic repeal; to replace the Education Coordinating Council with the
- 6 Alliance of Education Agency Heads; to provide for related matters; to make conforming
- 7 changes; to provide for legislative findings; to repeal conflicting laws; and for other
- 8 purposes.

## 9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 11 The General Assembly finds that:
- 12 (1) Current Georgian literacy rates are not where they need to be to support the workforce
- 13 needs of our growing economy, and it has been many years since there has been a
- systematic study of Georgia's efforts to support student and adult literacy efforts;

15 (2) A comprehensive study of all state resources and activities that are funded to support

- 16 improved literacy outcomes is needed. This study should also set recommended priorities
- 17 for future investments and strategies; and
- 18 (3) Georgia must have a very specific goal that sets clearly defined measures for third,
- 19 fifth, and eighth grade reading outcomes.
- SECTION 2.
- 21 Title 20 of the Official Code of Georgia Annotated, relating to education, is amended in
- 22 Chapter 1, relating to general provisions, by adding a new article to read as follows:
- 23 "ARTICLE 4
- 24 20-1-40.
- 25 As used in this article, the term:
- 26 (1) 'Council' means the Georgia Council on Literacy established under this article.
- 27 (2) 'Evidence based literacy instruction methods and curricula' means instructional
- 28 materials, instructional practices, and curricula that are scientifically based reading
- instruction, or multisensory language instruction, including oral language development,
- 30 phonological awareness, and phonics instruction that includes decoding and encoding,
- 31 <u>fluency, writing, vocabulary, and comprehension.</u>
- 32 20-1-41.
- 33 There is established the Georgia Council on Literacy for the purpose of conducting
- 34 comprehensive reviews of birth to postsecondary programs, the alignment of state support
- 35 for such programs, and other issues related to improving the literacy outcomes of Georgia
- 36 students.

- 37 <u>20-1-42.</u>
- 38 (a) The council shall be composed of 24 members as follows:
- 39 (1) The following members appointed by the Governor:
- 40 (A) A representative from the Sandra Dunagan Deal Center for Early Language and
- 41 <u>Literacy</u>;
- 42 (B) A representative from the Office of Public Library Services of the Board of
- 43 Regents of the University System of Georgia;
- 44 (C) Two individuals with knowledge, skills, and experience in birth to five-year-old
- 45 <u>early learning; and</u>
- 46 (D) Two individuals with knowledge, skills, and experience in literacy education;
- 47 (2) The following members appointed by the President of the Senate:
- 48 (A) The chairperson of the Senate Education and Youth Committee;
- 49 (B) The chairperson of the Senate Higher Education Committee;
- 50 (C) The chairperson of the Senate Appropriations Committee;
- 51 (D) Two members of the Senate from the minority caucus; and
- 52 (E) Four individuals to include a teacher, a local board of education member, a local
- 53 <u>school superintendent, and a literacy advocate; and</u>
- 54 (3) The following members appointed by the Speaker of the House of Representatives:
- 55 (A) The chairperson of the House Committee on Education;
- 56 (B) The chairperson of the House Committee on Higher Education;
- 57 (C) The chairperson of the House Committee on Appropriations;
- 58 (D) Two members of the House of Representatives from the minority caucus; and
- 59 (E) Four individuals to include a teacher, a local board of education member, a local
- school superintendent, and a literacy advocate.
- 61 (b) Each nonlegislative member of the council shall be appointed to serve until his or her
- 62 successor is duly appointed. Legislative members of the council shall serve until
- 63 completion of their current terms of office. Any member may be appointed to succeed

64 himself or herself on the council. If a member of the council is an elected or appointed

- official, such member, or his or her designee, shall be removed from the council if such
- 66 member no longer serves as such elected or appointed official.
- 67 (c) The Governor shall designate one of the members appointed pursuant to subsection (a)
- of this Code section the chairperson of the council. The council may elect other officers
- 69 as it deems necessary. The chairperson of the council may designate and appoint
- 70 committees from among the membership of the council as well as appoint other persons
- 71 to perform such functions as he or she may determine to be necessary as relevant to and
- 72 consistent with this article. The chairperson shall only vote to break a tie.
- 73 (d) The Governor shall direct the Alliance of Education Agency Heads provided for in
- Article 1 of Chapter 14 of this title to work with members of the council.
- 75 (e) The council shall be attached for administrative purposes only to the Office of Student
- 76 Achievement. The Office of Student Achievement shall provide staff support for the
- 77 council. The Office of Student Achievement shall use any funds specifically appropriated
- 78 to it to support the work of the council.
- 79 20-1-43.
- 80 (a) The council may conduct meetings at such places and times as it deems necessary or
- 81 convenient to enable it to fully and effectively exercise its powers, perform its duties, and
- 82 accomplish the objectives and purposes of this article; provided, however, that the council
- 83 shall meet not less than four times per year. The council shall hold meetings at the call of
- 84 the chairperson.
- 85 (b) A quorum for transacting business shall be a majority of the members of the council.
- 86 (c) Legislative members of the council shall receive the allowances provided for in Code
- 87 Section 28-1-8. Nonlegislative members of the council shall receive a daily expense
- allowance in the amount specified in subsection (b) of Code Section 45-7-21 as well as the
- 89 mileage or transportation allowance authorized for state employees. Members of the

90 council who are state officials, other than legislative members, or state employees shall 91 receive no compensation for their services on the council, but shall be reimbursed for 92 expenses incurred by them in the performance of their duties as members of the council in 93 the same manner as they are reimbursed for expenses in their capacities as state officials 94 or state employees. The funds necessary for the reimbursement of the expenses of state officials, other than legislative members, and state employees shall come from funds 95 96 appropriated to or otherwise available to their respective departments. All other funds 97 necessary to carry out the provisions of this article shall come from funds appropriated to

100 (a) The council shall have the following duties:

the Senate and the House of Representatives.

- (1) Review the conditions, needs, issues, and problems related to state literacy outcomes;
- make recommendations for legislation and appropriations to support improving such
- outcomes; and provide by November 30 each year a report of such review and
- recommendations to the Governor, the Office of Planning and Budget, the Speaker of the
- House of Representatives, and the President of the Senate;
- 106 (2) Evaluate and consider the best practices, experiences, and results of legislation in
- other states with regard to literacy improvements for students;
- 108 (3) Establish a common metric for literacy scores for kindergarten through grade 12
- utilizing current assessment instruments required for accountability purposes;
- (4) Provide public schools and local school systems with the common metric for literacy
- scores established by the council;
- 112 (5) Research and make recommendations on improving literacy rates for low-income
- students;
- 114 (6) Research and make recommendations on improving literacy rates for minority and
- English for speakers of other languages (ESOL) students;

116 (7) Research and make recommendations on improving literacy rates for students with

- 117 <u>characteristics of dyslexia;</u>
- (8) Set annual literacy goals and measure state-wide success;
- (9) Review changes or updates to QBE funding to enhance literacy instruction;
- 120 (10) Review and make recommendations on the alignment of teacher certifications to
- include evidence based literacy instruction and education degree program requirements;
- 122 (11) Review and make recommendations of evidence based literacy instruction methods
- and curricula resources and the professional development needed by current teachers for
- improvements in literacy instruction in pre-kindergarten through grade 12;
- 125 (12) Review state-wide birth to age five initiatives and suggest policy and appropriation
- changes; and
- 127 (13) Review best practices for community based literacy programs and make
- recommendations for improvement.
- 129 (b) The council shall be authorized to:
- 130 (1) Request and receive data from and review the records of appropriate state agencies
- to the greatest extent allowed by state and federal law;
- 132 (2) Seek and accept public or private grants, devises, and bequests;
- 133 (3) Enter into contracts or agreements through the council's chairperson necessary or
- incidental to the performance of its duties;
- 135 (4) Establish rules and procedures for conducting the business of the council;
- 136 (5) Conduct studies, hold public meetings, collect data, or take any other action the
- council deems necessary to fulfill its responsibilities; and
- 138 (6) Retain the services of attorneys, consultants, subject matter experts, economists,
- budget analysts, data analysts, statisticians, and other individuals or organizations as
- deemed appropriate by the council. Such services may be obtained through a request for
- proposal process conducted through the Office of Planning and Budget; provided,
- however, that any final selection shall be approved by the council.

- 144 The council shall be abolished and this article shall stand repealed on December 31, 2026."

## SECTION 3.

- 146 Said title is further amended in Article 1 of Chapter 14, relating to general provisions for
- 147 education accountability, by revising Code Section 20-14-8, relating to general powers and
- 148 duties, as follows:
- 149 "20-14-8.
- 150 The council alliance shall have the following general powers and duties, in addition to any
- and all other powers enumerated in this article, any or all of which may be exercised by the
- 152 council alliance directly or by the Office of Student Achievement under the direction and
- supervision of the <del>council</del> <u>alliance</u>:
- 154 (1) To foster coordination and cooperation among the chief officers of the departments,
- boards, and offices represented on the council alliance;
- 156 (2) To develop a seamless and integrated public education system;
- 157 (3) To require the shared and efficient expenditures for and utilization of facilities,
- personnel, and other resources;
- 159 (4) To require the seamless coordination of curriculum among the departments, boards,
- and offices represented on the <del>council</del> alliance;
- 161 (5) To require reasonable ease of transition for students among the educational
- institutions represented on the <del>council</del> alliance;
- 163 (6) To establish and require high and necessary levels of student achievement at all
- levels of education;
- 165 (7) To exercise oversight of accountability systems that are within or among the
- departments, boards, and offices represented on the council alliance and develop overlay
- accountability systems through the Office of Student Achievement;

168 (8) To exercise supervision and oversight over the Office of Student Achievement

- created in Part 2 of Article 2 of this chapter;
- 170 (9) To coordinate the activities of state, regional, and local cooperative public education
- agencies, offices, or councils, including, but not limited to, the state's regional educational
- service agencies or other such groups that may be created in addition or in their place;
- 173 (10) To focus on literacy improvements for Georgia students;
- 174 (11) To work with the Georgia Council on Literacy to ensure the availability and quality
- of the education work force workforce through preparation, professional development,
- and nontraditional routes to employment;
- 177 (11)(12) To oversee the development and implementation of a comprehensive
- system-wide education student information system that will support the implementation
- of an education accountability system and improve the seamless operation of public
- 180 education;
- 181 (12)(13) To simplify rules and regulations by all departments, boards, and offices
- represented on the council alliance;
- 183 (13)(14) To develop a state-wide mentoring program that enhances student achievement
- at all levels of public education;
- 185 (14)(15) To establish and coordinate a school safety collaborative with representation
- from agencies and organizations designated by the council alliance to improve the school
- climate and enhance school safety; and
- 188 (15)(16) To mediate disputes among the Department of Education, the University
- 189 System of Georgia, the Technical College System of Georgia, the Professional Standards
- 190 Commission, the Department of Early Care and Learning, and the Office of Student
- Achievement in matters regarding accountability or education system seamlessness."

192 **SECTION 4.** 

- 193 Said title is further amended by revising subsection (d) of Code Section 20-14-35, relating
- 194 to office powers, on-site audits, reporting findings and recommendations, and authorization
- 195 of other school audits, as follows:
- 196 "(d) The auditors shall report to the local board of education, the local school council, and
- 197 appropriate school administrators and shall report findings and recommendations
- 198 concerning any necessary improvements or intervention strategies. School audit reports
- shall be provided to the council alliance and the State Board of Education."

200 SECTION 5.

- 201 Said title is further amended by replacing "Education Coordinating Council" and "council"
- 202 with "Alliance of Education Agency Heads" and "alliance", respectively, wherever the
- 203 former terms occur in:
- 204 (1) Code Section 20-2-271, relating to development of regional improvement plan,
- 205 introduction of core services, instructional care teams, and establishment of alternative
- 206 methods of teacher certification;
- 207 (2) Code Section 20-2-320, relating to state-wide comprehensive educational information
- 208 system and identification of data to implement Quality Basic Education Program:
- 209 (3) Code Section 20-14-1, relating to responsibility of council;
- 210 (4) Code Section 20-14-2, relating to creation of council;
- 211 (5) Code Section 20-14-3, relating to membership, officers, and meetings;
- 212 (6) Code Section 20-14-4, relating to quorum and committees;
- 213 (7) Code Section 20-14-5, relating to annual reports;
- 214 (8) Code Section 20-14-6, relating to selection of personnel to support council;
- 215 (9) Code Section 20-14-7, relating to powers of council;
- 216 (10) Code Section 20-14-9, relating to access to records or data;

217 (11) Code Section 20-14-10, relating to decisions or actions by council directing action by

- 218 department, board, or office;
- 219 (12) Code Section 20-14-11, relating to appointment by Governor of study commissions,
- 220 findings and recommendations, and staff and expenses;
- 221 (13) Code Section 20-14-20, relating to definitions;
- 222 (14) Code Section 20-14-25, relating to creation, director, authority, seal, and
- 223 administrative assignment;
- 224 (15) Code Section 20-14-26, relating to duties; and
- 225 (16) Code Section 20-14-27, relating to required report and publication format.

226 **SECTION 6.** 

227 All laws and parts of laws in conflict with this Act are repealed.
