A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to provide a new charter for the City of Stockbridge, approved April 4,  
2 1991 (Ga. L. 1991, p. 4359), as amended, so as to change the corporate boundaries of the  
3 city; to provide for related matters; to provide for a referendum; to provide for contingent  
4 effective dates and automatic repeal; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1.**

7 An Act to provide a new charter for the City of Stockbridge, approved April 4, 1991  
8 (Ga. L. 1991, p. 4359), as amended, is amended in Section 1.11 by adding at the end of the  
9 section the following:

10 "In addition to the other territory described in this section, the City of Stockbridge shall also  
11 include the territory contained in the following properties included in the tax parcels set  
12 forth below as those tax parcels exist on the tax rolls and the tax maps of Henry County for

269 **SECTION 2.**

270 The election superintendent of Henry County shall call and conduct an election as provided  
 271 in this section for the purpose of submitting this Act to the electors of the territory sought to  
 272 be annexed into the City of Stockbridge under this Act for approval or rejection. The  
 273 election superintendent shall conduct such election on the Tuesday after the first Monday in  
 274 November, 2017, and shall issue the call and conduct such election as provided by general  
 275 law. The election superintendent shall cause the date and purpose of the election to be  
 276 published once a week for two weeks immediately preceding the date thereof in the official  
 277 organ of Henry County. The ballot shall have written or printed thereon the words:

278 "( ) YES Shall the Act be approved which annexes certain land into the City of  
 279 ( ) NO Stockbridge?"

280 All persons desiring to vote for approval of the annexation shall vote "Yes" and all persons  
 281 desiring to vote for rejection of the annexation shall vote "No." If more than one-half of the  
 282 votes cast on such question are for approval of the annexation, then Section 1 of this Act  
 283 shall become effective on January 1, 2018. If more than one-half of the votes cast on such



284 question are for rejection of the annexation or if the election is not held as provided in this  
285 section, then this Act shall automatically be repealed on January 1, 2018. The expense of  
286 such election shall be borne by the City of Stockbridge. It shall be the election  
287 superintendent's duty to certify the result thereof to the Secretary of State.

288 **SECTION 3.**

289 Except as provided in Section 2 of this Act, this Act shall become effective upon its approval  
290 by the Governor or upon its becoming law without such approval.

291 **SECTION 4.**

292 All laws and parts of laws in conflict with this Act are repealed.
