## A RESOLUTION

- 1 Honoring the life of Mr. James Slaton "Jay" Shaw and dedicating a road in his memory; and
- 2 for other purposes.
- 3 WHEREAS, Mr. James Slaton "Jay" Shaw was widely recognized by the citizens of this state
- 4 for the vital role that he played in leadership and his deep personal commitment to the
- 5 welfare of the citizens of Georgia; and
- 6 WHEREAS, Mr. Shaw attended Abraham Baldwin Agriculture College before establishing
- 7 The Jay Shaw Company, a real estate and insurance agency focused on providing financial
- 8 support and involvement for communities in and around his hometown of Lakeland, Georgia;
- 9 and
- 10 WHEREAS, he diligently and conscientiously devoted his time, talents, and energy to his
- 11 constituents as a member of the House of Representatives for 17 years as a representative for
- 12 House District 176 and chairman of the community health subcommittee for the House
- 13 Committee on Appropriations; and
- 14 WHEREAS, Mr. Shaw served as mayor of Lakeland for ten years, a position in which his
- 15 leadership and diplomacy were instrumental in advancing the city's position in the region and
- 16 preserving Banks Lake as a historic landmark;
- 17 WHEREAS, he served on the State Transportation Board from 2010 to 2015 and led the
- 18 board as chairman in 2013; and
- 19 WHEREAS, during his time serving this state, Mr. Shaw focused on advancing healthcare
- 20 in rural areas, improving Georgia's transportation system, and promoting balance and
- 21 positive reform; and

WHEREAS, a man of deep and abiding faith, Mr. Shaw was a trustee and board member of

- 23 Unity United Methodist Church; and
- 24 WHEREAS, his legacy lives on through his wife of 45 years, Libby Shaw; his devoted sons
- and daughters-in-law, Jason, Sam, Katy, and Christa; and his adoring grandchildren, Jenna,
- 26 Brady, Anne Harvey, and Slaton; and
- 27 WHEREAS, it is abundantly fitting and proper that the extraordinary life of this
- 28 distinguished Georgian be recognized by dedicating a road in his honor.
- 29 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 30 ASSEMBLY OF GEORGIA that the portion of U.S. Highway 22/State Route 31 from the
- 31 intersection of State Route 11 and State Route 31 in Lakeland to the intersection of State
- 32 Route 7 and State Route 31 in Valdosta in Lowndes County is dedicated as the James Slaton
- 33 "Jay" Shaw Memorial Highway.
- 34 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 35 directed to erect and maintain appropriate signs dedicating the James Slaton "Jay" Shaw
- 36 Memorial Highway.
- 37 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 38 to make appropriate copies of this resolution available for distribution to the family of Mr.
- 39 James Slaton "Jay" Shaw Memorial Highway and to the Department of Transportation.
