- 3 WHEREAS, Dr. Lora Darrisaw joined the GBI Medical Examiner's Office as an associate
- 4 medical examiner in 2002, and she is currently the Director of Pediatric Forensic Pathology
- 5 at the Georgia Bureau of Investigation (GBI); and
- 6 WHEREAS, she specializes in pediatric pathology and the evaluation of fatal and nonfatal
- 7 pediatric injury, and as one of the few pediatric pathologists in the country, Dr. Darrisaw is
- 8 a leader in her field and an incredible asset to our state CFR program; and
- 9 WHEREAS, Dr. Darrisaw has supported nearly all of the county CFR committees with her
- 10 exceptional work, and she is the most requested pathologist for juvenile cases due to her
- 11 consistently thorough assessments; and
- 12 WHEREAS, many county coroners and CFR committee members express sincere
- 13 appreciation for her work on juvenile cases, especially the difficult sleep-related cases, and
- 14 are confident that nothing was missed, and for many of the CFR committees,
- 15 Dr. Lora Darrisaw's work is truly the Gold Standard; and
- 16 WHEREAS, she routinely reviews scene photos and sudden unexpected infant death
- 17 investigation (SUIDI) forms to support her autopsy findings, and because of that her
- determination of cause and manner is consistently thorough and accurate; and

- 20 (SDY) project, a grant initiative through the CDC, and as a clinical reviewer she will
