A RESOLUTION

- 1 Recognizing March 19, 2019, as Georgia Hearing Day at the state capitol; and for other
- 2 purposes.
- 3 WHEREAS, hearing plays a critical role in communication and personal relationships,
- 4 overall health outcomes, psychological well-being, and safety; and
- 5 WHEREAS, hearing loss has been tied to cognitive decline, dementia, falls, depression, and
- 6 isolation; can be a symptom of an underlying medical condition, including but not limited
- 7 to infections, tumors, otosclerosis, and Meniere's disease; and is typically irreversible; and
- 8 WHEREAS, a study conducted by the Better Hearing Institute concluded that untreated
- 9 hearing loss has significant income ramifications, including negatively impacting household
- income by up to \$12,000 annually and costing \$122 billion in lost earnings in the United
- 11 States; and
- 12 WHEREAS, noise induced hearing loss is a preventable and significant, though often
- 13 unrecognized, health problem among American adults and is a growing problem with
- 14 adolescents due to overamplification of personal listening devices; and
- 15 WHEREAS, according to the National Institutes of Deafness and Other Communications
- 16 Disorders (NIDCD), more than 37 million American adults (15 percent) report some trouble
- 17 hearing and approximately 28.2 million American adults could benefit from using hearing
- 18 aids; and
- 19 WHEREAS, according to the NIDCD, fewer than 30 percent of adults aged 70 and older and
- 20 16 percent of adults aged 20 to 69 who experience hearing loss and who could benefit from
- 21 hearing aids have ever used them; and

WHEREAS, the Georgia Society of Hearing Professionals, a chapter of the International

- Hearing Society, is composed of hearing health care professionals, including hearing aid
- 24 specialists and audiologists, who are trained and specialize in the identification and
- 25 assessment of hearing loss, rehabilitation through the use of hearing aids and related devices,
- and counseling; and
- 27 WHEREAS, Georgia Hearing Day, founded by the Georgia Society of Hearing
- 28 Professionals, is observed on March 19 to raise awareness of how to prevent deafness and
- 29 hearing loss and to promote ear and hearing care across the world; and
- 30 WHEREAS, the theme of Georgia Hearing Day 2019 is "Hearing the Future," and the focus
- 31 of this important day is to promote hearing loss prevention awareness and access for
- 32 individuals with hearing loss to necessary rehabilitation services and the communication
- 33 tools they require.
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 35 recognize March 19, 2019, as Georgia Hearing Day at the state capitol to encourage the
- 36 citizens of Georgia to protect their hearing and seek the services of a licensed hearing health
- 37 care professional, such as a hearing aid specialist, audiologist, or otolaryngologist, for regular
- 38 hearing checks.
- 39 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 40 to make appropriate copies of this resolution available for distribution to the public and the
- 41 press.
