- 21 WHEREAS, Representative Smyre has served with honor and distinction with the Georgia
- House of Representatives, and his vision and unyielding commitment to excellence will be
- 23 sorely missed upon the occasion of his retirement; and
- 24 WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for
- 25 integrity, intelligence, fairness, and kindness; and
- 26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 27 remarkable and distinguished Georgian and esteemed legislator be appropriately recognized.
