HOUSE BILL NO. 307

2 RELATING TO ELECTION OF HIGHWAY DISTRICT COMMISSIONERS; AMENDING CHAPTER  
3 13, TITLE 40, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 40-1305D,  
4 IDAHO CODE, TO PROVIDE FOR HIGHWAY DISTRICT COMMISSIONER TERMS OF OF-  
5 FICE; AND DECLARING AN EMERGENCY.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Chapter 13, Title 40, Idaho Code, be, and the same is  
8 hereby amended by the addition thereto of a NEW SECTION, to be known and des-  
9 ignated as Section 40-1305D, Idaho Code, and to read as follows:

10 40-1305D. TRANSITION OF HIGHWAY DISTRICT COMMISSIONER ELECTIONS. For  
11 the purpose of achieving an orderly transition for highway district commis-  
12 sioner elections held in odd-numbered years, the following schedule shall be  
13 followed:

14 (1) For highway district commissioner(s) elected in 2007, said commis-  
15 sioner(s) shall serve their full term with said term expiring on October 1,  
16 2011.

17 (2) For highway district commissioner(s) elected in 2008, said com-  
18 missioner(s) shall serve their full term with said term expiring on July 1,  
19 2013.

20 (3) For highway district commissioner(s) elected in 2009, said commis-  
21 sioner(s) shall serve their full term with said term expiring on October 1,  
22 2013.

23 (4) For highway district commissioner(s) elected in 2010, said com-  
24 missioner(s) shall serve their full term with said term expiring on July 1,  
25 2015.

26 (5) For highway district commissioner(s) elected in 2011, said commis-  
27 sioner(s) shall serve a four (4) year term, shall take office on July 1, 2011,  
28 and said term shall expire on July 1, 2015.

29 (6) In the case where a highway district commissioner(s) elected in  
30 2007 does not stand for reelection or is defeated in 2011, said highway dis-  
31 trict commissioner(s) shall serve their full term with said term expiring  
32 on October 1, 2011. Highway district commissioner(s) elected pursuant to  
33 subsection (5) of this section shall than take office on October 1, 2011.

34 SECTION 2. An emergency existing therefor, which emergency is hereby  
35 declared to exist, this act shall be in full force and effect on and after its  
36 passage and approval.
