7 AMENDING SECTION 34-410A, IDAHO CODE, TO REVISE PROVISIONS REGARDING

9 CODE, TO REVISE PROVISIONS REGARDING VOTER REGISTRATION INFORMATION;

17 49-315, IDAHO CODE, TO PROVIDE FOR UNITED STATES CITIZENSHIP AND TO
18 MAKE TECHNICAL CORRECTIONS; AMENDING SECTION 49-321, IDAHO CODE, TO
19 PROVIDE FOR PROOF OF UNITED STATES CITIZENSHIP AND TO MAKE A TECHNICAL
20 CORRECTION; AMENDING SECTION 49-2444, IDAHO CODE, TO PROVIDE FOR UNITED
21 STATES CITIZENSHIP STATUS AND TO MAKE TECHNICAL CORRECTIONS; PROVIDING
22 SEVERABILITY; AND DECLARING AN EMERGENCY.

24 Be It Enacted by the Legislature of the State of Idaho:

25 SECTION 1. That Section 34-217, Idaho Code, be, and the same is hereby
26 amended to read as follows:

27 34-217. RETENTION OF COUNTY ELECTION RECORDS. County election
28 records shall be maintained by the county clerk for the time periods outlined
29 in this section. Records shall be maintained for the period specified be-
30 ginning with the date the record is created or has become no longer valid,
31 whichever is greater.

32 (1) The following records shall be retained for not less than five (5)
33 years:

34 (a) Voter registration cards for electors whose registration has been
35 terminated;

36 (b) Correspondence relating to an elector's voter registration;

37 (c) Combination election record and poll book, including the ballot ac-
38 counting page;

39 (d) Declaration of candidacy and petition of candidacy forms filed with
40 the county clerk;

41 (e) Maps of precinct boundaries with legal descriptions;

42 (f) List of absentee voters; and

1 (g) County initiatives and petitions that qualify for placement on the
2 ballot.

3 (2) The following shall be retained for two (2) years:

4 (a) Completed absentee ballot request forms;

5 (b) Tally books;

6 (c) Voted ballots;

7 (d) Any ballots that were required to be duplicated before being
8 counted;

9 (e) Certified lists of candidates or declaration of candidacy forms
10 from special districts used for ballot preparation;

11 (f) Certified ballot language from special districts for any question
12 placed on the ballot; and

13 (g) Absentee ballot affidavit envelopes, including the indication of
14 the signature's acceptance or rejection-;

15 ~~(3) The following shall be maintained for one (1) year:~~

16 ~~(a) Notice of election;~~

17 ~~(b) Personal identification affidavit;~~

18 (ei) Ballot tracking logs;

19 (ej) Automated tabulation election logs;

20 (ek) Copy of the election definition and program used in tabulating
21 ballots electronically and in the ballot-marking device; and

22 (fl) Record of the number of ballots printed and furnished to each
23 polling place.

24 (43) Other election supplies, including but not limited to unused bal-
25 lots, official election ballot identification or official ballot stamps,
26 receipts for supplies, and spoiled ballots, may be disposed of sixty (60)
27 days following the deadline for requesting a recount or filing an election
28 contest pursuant to chapters 20 and 21, title 34, Idaho Code.

29 SECTION 2. That Section 34-408A, Idaho Code, be, and the same is hereby
30 amended to read as follows:

31 34-408A. ELECTION DAY REGISTRATION. (1) An individual who is eligible
32 to vote may register on election day by appearing in person at the polling
33 place for the precinct in which the individual maintains residence, ~~by~~ com-
34 pleting a registration application, making an oath in the form prescribed
35 by the secretary of state, and providing proof of identity, residence, and
36 United States citizenship. An individual may ~~prove residence~~ provide such
37 proof for purposes of registering by: showing one (1) photo identification
38 document, one (1) address verification document, and one (1) proof of United
39 States citizenship document.

40 (a) Acceptable photo identification documents are:

41 ~~(1) Showing an~~ (i) A current Idaho driver's license or Idaho iden-
42 tification card issued through the Idaho transportation depart-
43 ment of transportation; or

44 (ii) A current United States passport;

45 (iii) A current active United States military identification
46 card;

47 (iv) A current tribal identification card issued by a federally
48 recognized Indian tribe as defined in section 67-4001, Idaho Code,
49 that displays the individual's date of birth; or

1 (v) A current Idaho license to carry concealed weapons that dis-
 2 plays the individual's date of birth and physical address located
 3 in Idaho.

4 (b) Acceptable address verification documents must display the indi-
 5 vidual's current address and a date that is at least thirty (30) days
 6 prior to the date of the election. Acceptable address verification doc-
 7 uments are:

8 (i) A utility bill, not including a cellular phone bill, that is
 9 no more than six (6) months old;

10 (ii) A current residential lease agreement, rental agreement,
 11 mortgage statement, or deed of trust;

12 (iii) A W-2 or 1099 federal tax form for the most recent available
 13 tax year;

14 (iv) A military leave and earnings statement showing the Idaho
 15 residency of an individual on active military duty deployed out-
 16 side the state of Idaho; or

17 (v) A government record showing the individual as having paid
 18 property taxes at the address within the last year.

19 (c) Acceptable proof of United States citizenship is the original or
 20 legible photocopy of:

21 (i) An Idaho driver's license or Idaho identification card is-
 22 ssued through the Idaho transportation department that shows proof
 23 of United States citizenship;

24 (ii) A state driver's license or state identification card issued
 25 by the equivalent governmental agency of another state or terri-
 26 tory within the United States if the agency indicates on the card
 27 that the person has provided satisfactory proof of United States
 28 citizenship;

29 (iii) The individual's birth certificate that verifies citizen-
 30 ship accompanied by a current photo identification document as set
 31 forth in paragraph (a) of this subsection that shows the same name
 32 or a document verifying the reason for the name change;

33 (iv) The individual's United States passport identifying the in-
 34 dividual and the passport number;

35 (v) The individual's United States naturalization documents; or

36 (vi) The individual's bureau of Indian affairs card, tribal
 37 treaty card, or tribal enrollment verification that shows the in-
 38 dividual's photo, date of birth, and declaration of United States
 39 citizenship.

40 (2) ~~Showing any document which contains a valid address in the precinct~~
 41 ~~together with a picture identification card; or~~

42 ~~(3) Showing a current valid student photo identification card from~~
 43 ~~a postsecondary educational institution in Idaho accompanied with a cur-~~
 44 ~~rent student fee statement that contains the student's valid address in the~~
 45 ~~precinct. Election day registration provided in this section shall apply to~~
 46 ~~all elections conducted under title 34, Idaho Code, and to school district~~
 47 ~~and municipal elections.~~

48 (3) An individual who is eligible to vote may also register, upon pro-
 49 viding proof of residence, at the "absent electors' polling place" provided
 50 in section 34-1006, Idaho Code.

1 SECTION 3. That Section 34-409, Idaho Code, be, and the same is hereby
2 amended to read as follows:

3 34-409. ELECTRONIC REGISTRATION. (1) The office of the secretary of
4 state ~~may~~ shall create and maintain an electronic system for voter registra-
5 tion that is publicly available on its official website. Any qualified elec-
6 tor who has a current valid driver's license or identification card issued
7 pursuant to title 49, Idaho Code, that reflects the person's current princi-
8 pal place of residence, ~~may~~ register to vote by submitting a completed voter
9 registration application electronically through such website. Electronic
10 voter registration applications shall be submitted before the close of reg-
11 istration as provided in section 34-408, Idaho Code.

12 (2) The electronic voter registration application shall be in a form
13 prescribed by the secretary of state and shall:

14 (a) Require the information under oath or affirmation set forth in sec-
15 tion 34-411, Idaho Code;

16 (b) Include notice of the requirement to provide personal identifi-
17 cation before voting at the polls as set forth in sections 34-1113 and
18 34-1114, Idaho Code; and

19 (c) Require an electronic signature of the applicant.

20 (3) The office of the secretary of state shall obtain a digital copy
21 of the applicant's driver's license or identification card signature from
22 the Idaho transportation department. The Idaho transportation department
23 shall, upon request of the office of the secretary of state, provide a dig-
24 ital copy of the applicant's driver's license or identification card signa-
25 ture.

26 (4) Upon receipt of a completed voter registration application and a
27 digital copy of the applicant's driver's license or identification card sig-
28 nature from the Idaho transportation department, the office of the secre-
29 tary of state shall send the information to the county clerk for the county
30 in which the applicant resides. The county clerk shall prepare and issue to
31 each elector registering electronically a verification of registration con-
32 taining the name and residence of the elector and the name or number of the
33 precinct in which the elector resides. Such verification of registration
34 ~~may shall~~ be sent by nonforwardable ~~first-class~~ first class mail ~~or by elec-~~
35 ~~tronic mail at the elector's option~~. If a verification is returned undeliv-
36 erable, then the county clerk shall remove the elector from the register of
37 electors, unless the elector is a person subject to the uniformed and over-
38 seas citizens absentee voting act, 52 U.S.C. 20301 et seq.

39 (5) An applicant using the electronic system for voter registration
40 pursuant to this section shall not be required to complete a printed regis-
41 tration card.

42 (6) The office of the secretary of state shall use such security mea-
43 sures necessary to ensure the accuracy and integrity of an electronically
44 submitted voter registration application.

45 SECTION 4. That Section 34-410, Idaho Code, be, and the same is hereby
46 amended to read as follows:

47 34-410. MAIL REGISTRATION. (1) Any elector may register by mail for
48 any election. Any mail registration application must be received by the

1 county clerk prior to the close of registration as provided in section
2 34-408, Idaho Code, provided that any mail registration application post-
3 marked not later than twenty-five (25) days prior to an election shall be
4 deemed timely.

5 (2) The secretary of state shall prescribe the form for the mail regis-
6 tration application. This mail application form shall be available for dis-
7 tribution through governmental and private entities, with particular empha-
8 sis on making them available for organized voter registration programs.

9 (3) Any federal mail registration form adopted pursuant to the provi-
10 sions of the national voter registration act of 1993 (P.L. 103-31) shall also
11 be accepted as a valid registration, if such form is postmarked not later
12 than twenty-five (25) days prior to an election.

13 (4) The county clerk shall prepare and issue by first class nonforward-
14 able mail to the residence address of each elector registering by mail a ver-
15 ification of registration containing the name and residence of the elector
16 and the name or number of the precinct in which the elector resides.

17 (5) A verification returned undeliverable shall cause the county clerk
18 to remove the elector's card from the register of electors, unless the elec-
19 tor is a person subject to the uniformed and overseas citizens absentee vot-
20 ing act, 52 U.S.C. 20301 et seq.

21 (6) Any registration received by mail that does not include the number
22 of the elector's current driver's license or state identification card is-
23 sued by the Idaho transportation department must be accompanied by a legible
24 photocopy of a proof of United States citizenship document acceptable under
25 section 34-408A(1) (c), Idaho Code.

26 (7) As required by the help America vote act of 2002 (P.L. 107-252), a
27 copy of proper identification will be required prior to issuance of a ballot
28 to anyone who has registered by mail and has not previously voted in an elec-
29 tion for federal office in the state. Proper identification consists of:

30 (1a) A current and valid photo identification; or

31 (2b) A copy of a current utility bill, bank statement, government
32 check, paycheck, or other government document that shows the name and
33 address of the voter.

34 SECTION 5. That Section 34-410A, Idaho Code, be, and the same is hereby
35 amended to read as follows:

36 34-410A. ABSENTEE REGISTRATION FOR UNIFORMED AND OVERSEAS CITI-
37 ZENS. Whenever provision is made for absentee voting by a statute of the
38 United States, including the ~~"Uniformed and Overseas Citizens Absentee~~
39 ~~Voting Act" (42 U.S.C. 1973ff.)~~ uniformed and overseas citizens absentee
40 voting act, 52 U.S.C. 20301 et seq., an application for an absentee ballot
41 made under that law may be given the same effect as an application for an
42 absentee ballot made under chapter 10, title 34, Idaho Code. Provided, how-
43 ever, if the individual uses the federal application form, is registering to
44 vote in Idaho for the first time, and does not provide the voter identifica-
45 tion required by Idaho law, such applicant shall be eligible to vote only for
46 federal offices.

47 SECTION 6. That Section 34-411, Idaho Code, be, and the same is hereby
48 amended to read as follows:

1 34-411. APPLICATION FOR REGISTRATION -- CONTENTS. (1) Each elector
2 who requests registration shall supply the following information under oath
3 or affirmation:

4 (a) Full legal name, including the full first, full middle, and full
5 last name, and sex-;

6 (b) Mailing address, residence address, or any other necessary infor-
7 mation definitely locating the elector's residence-;

8 (c) The period of time preceding the date of registration during which
9 the elector has resided in the state-;

10 (d) ~~Whether or not~~ Acceptable proof that the elector is a United States
11 citizen- pursuant to section 34-408A(1) (c), Idaho Code;

12 (e) That the elector is under no legal disqualifications to vote-;

13 (f) The county and state where the elector was previously registered,
14 if any-;

15 (g) Date of birth-; and

16 (h) Current driver's license number or identification card issued
17 by the Idaho transportation department. In the absence of an Idaho
18 driver's license or state-issued identification card, the last four (4)
19 digits of the elector's social security number.

20 (2) As provided for in section 34-404, Idaho Code, each elector shall
21 select an affiliation with a political party qualified to participate in
22 elections pursuant to section 34-501, Idaho Code, or select to be desig-
23 nated as "unaffiliated." The selection of party affiliation or designation
24 as "unaffiliated" shall be maintained within the voter registration sys-
25 tem as provided for in section 34-437A, Idaho Code. If an elector shall
26 fail or refuse to make such a selection, the county clerk shall record as
27 "unaffiliated" such elector within the voter registration system as pro-
28 vided for in section 34-437A, Idaho Code.

29 (3) Any elector who ~~shall supply~~ supplies any information under subsec-
30 tion (1) of this section, knowing it to be false, is guilty of perjury.

31 (4) Each elector who requests registration may, at the elector's op-
32 tion, supply the elector's telephone number. If the telephone number is sup-
33 plied by the elector, the telephone number shall be available to the public.

34 SECTION 7. That Chapter 4, Title 34, Idaho Code, be, and the same is
35 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
36 ignated as Section 34-421, Idaho Code, and to read as follows:

37 34-421. ELECTION INTEGRITY FUND. There is hereby created in the state
38 treasury the election integrity fund. The moneys in the fund are continu-
39 ously appropriated for the purpose of defraying the cost of providing free
40 state identification cards for voting purposes pursuant to section 49-2444,
41 Idaho Code. The secretary of state shall, upon submission of his annual bud-
42 get request, furnish an estimate of the ending balance of the fund for the end
43 of the current fiscal year.

44 SECTION 8. That Section 34-1106, Idaho Code, be, and the same is hereby
45 amended to read as follows:

46 34-1106. SIGNING COMBINATION ELECTION RECORD AND POLL BOOK -- DELIV-
47 ERY OF BALLOT TO ELECTOR. (1) An elector desiring to vote shall state his

1 name and address to the judge or clerk in charge of the combination election
2 record and poll book.

3 (2) Before receiving his ballot, each elector shall sign his name in
4 the combination election record and poll book following his name therein
5 and show a valid photo identification as provided for in section 34-1113,
6 Idaho Code, ~~or personal identification affidavit as provided for in section~~
7 ~~34-1114, Idaho Code.~~

8 (3) No person shall knowingly sign his name in the combination election
9 record and poll book if his residence address is not within that precinct at
10 the time of signing.

11 (4) If the residence address of a person contained in the combination
12 election record and poll book is incorrectly given due to an error in prepa-
13 ration of the combination election record and poll book, the judge shall as-
14 certain the correct address and make the necessary correction.

15 (5) The elector shall then be given the appropriate ballots ~~which that~~
16 have been marked with the official election ballot identification and shall
17 be given folding instructions for such ballots.

18 SECTION 9. That Section 34-1113, Idaho Code, be, and the same is hereby
19 amended to read as follows:

20 34-1113. IDENTIFICATION AT THE POLLS. All voters shall be required
21 to provide personal identification before voting at the polls or at absent
22 electors polling places as required by section 34-1006, Idaho Code. The per-
23 sonal identification that may be presented shall be ~~one (1) of the following:~~
24 a document acceptable under section 34-408A(1) (a), Idaho Code.

25 ~~(1) An Idaho driver's license or identification card issued by the~~
26 ~~Idaho transportation department;~~

27 ~~(2) A passport or an identification card, including a photograph, is-~~
28 ~~sued by an agency of the United States government;~~

29 ~~(3) A tribal identification card, including a photograph;~~

30 ~~(4) A current student identification card, including a photograph, is-~~
31 ~~sued by a high school or an accredited institution of higher education, in-~~
32 ~~cluding a university, college or technical school, located within the state~~
33 ~~of Idaho; or~~

34 ~~(5) A license to carry concealed weapons issued under section 18-3302,~~
35 ~~Idaho Code, or an enhanced license to carry concealed weapons issued under~~
36 ~~section 18-3302K, Idaho Code.~~

37 SECTION 10. That Section 49-306, Idaho Code, be, and the same is hereby
38 amended to read as follows:

39 49-306. APPLICATION FOR DRIVER'S LICENSE, INSTRUCTION PERMIT,
40 COMMERCIAL LEARNER'S PERMIT OR RESTRICTED SCHOOL ATTENDANCE DRIVING PER-
41 MIT. (1) Every application for any instruction permit, restricted school
42 attendance driving permit, or for a driver's license shall be made upon
43 a form furnished by the department and shall be verified by the applicant
44 before a person authorized to administer oaths. Officers and employees of
45 the department, agents authorized by the department, and sheriffs and their
46 deputies are authorized to administer the oaths without charge. Every ap-

1 plication for a permit, extension or driver's license shall be accompanied
2 by the following fee, none of which is refundable:

- 3 (a) Class A, B, C (4-year) license with endorsements --
4 age 21 years and older\$40.00
5 (b) Class A, B, C (3-year) license with endorsements --
6 age 18 to 21 years\$30.00
7 (c) Class A, B, C (1-year) license with endorsements --
8 age 20 years\$15.00
9 (d) Class D (3-year) license -- under age 18 years\$30.00
10 (e) Class D (3-year) license -- age 18 to 21 years\$30.00
11 (f) Class D (1-year) license -- age 17 years or age 20 years\$20.00
12 (g) Four-year Class D license -- age 21 years and older\$35.00
13 (h) Eight-year Class D license -- age 21 to 63 years\$60.00
14 (i) Commercial learner's permit\$29.00
15 (j) Class D instruction permit or supervised instruction permit
16\$20.00
17 (k) Duplicate driver's license or permit issued under
18 section 49-318, Idaho Code\$20.00
19 (l) Driver's license extension issued under section
20 49-319, Idaho Code\$10.00
21 (m) License classification change (upgrade)\$30.00
22 (n) Endorsement addition\$20.00
23 (o) Class A, B, C skills tests not more than\$200.00
24 (p) Class D skills test not more than\$35.00
25 (q) Motorcycle endorsement skills test not more than\$25.00
26 (r) Knowledge test\$ 5.00
27 (s) Seasonal driver's license\$44.00
28 (t) Onetime motorcycle "M" endorsement\$15.00
29 (u) Motorcycle endorsement instruction permit\$15.00
30 (v) Restricted driving permit or restricted school attendance
31 driving permit\$60.00
32 (2) A person who applies for a driver's license or a driver's license
33 renewal may designate a voluntary contribution of two dollars (\$2.00) for
34 the purpose of promoting and supporting organ donation. Such a contribution
35 shall be treated as a voluntary contribution to the organ donation contribu-
36 tion fund created in section 49-2447, Idaho Code, and not as a driver's li-
37 cense fee.
38 (3) Every application shall state the true and full name, date of birth,
39 sex, declaration of Idaho residency, Idaho residence address and mailing ad-
40 dress, if different, of the applicant, height, weight, hair color, and eye
41 color, and the applicant's social security number as verified by the social
42 security administration. If an applicant has submitted an application pur-
43 suant to the provisions of chapter 58, title 19, Idaho Code, then the appli-
44 cant may state, in his or her application pursuant to this section, the ap-
45 plicant's alternative Idaho mailing address in place of his or her Idaho res-
46 idence address and mailing address. Notwithstanding the provisions of sec-
47 tion 49-303(13), Idaho Code, an applicant for a nondomiciled class A, B or
48 C driver's license or nondomiciled commercial learner's permit having res-
49 idency in a state that is prohibited from issuing class A, B or C driver's

1 licenses or commercial learner's permits, as provided in 49 CFR 384, is ex-
2 cepted from providing proof of Idaho residency and an Idaho mailing address.

3 (a) The requirement that an applicant provide a social security number
4 as verified by the social security administration shall apply only to
5 applicants who have been assigned a social security number.

6 (b) An applicant who has not been assigned a social security number
7 shall:

8 (i) Present written verification from the social security admin-
9 istration that the applicant has not been assigned a social secu-
10 rity number; and

11 (ii) Submit a birth certificate, passport or other documentary
12 evidence issued by an entity other than a state or the United
13 States; and

14 (iii) Submit such proof as the department may require that the ap-
15 plicant is lawfully present in the United States.

16 A driver's license, commercial learner's permit or any instruction
17 permit issued on and after January 1, 1993, shall not contain an appli-
18 cant's social security number. Applications on file shall be exempt
19 from disclosure except as provided in sections 49-202, 49-203, 49-203A
20 and 49-204, Idaho Code.

21 (c) Every application for a class A, B or C license shall state where the
22 applicant has been licensed for the preceding ten (10) years and under
23 which of the following driving categories the applicant will operate:

24 (i) Non-excepted interstate. The applicant operates or expects
25 to operate in interstate commerce, and is required to provide a
26 medical examiner's certificate;

27 (ii) Excepted interstate. The applicant operates or expects to
28 operate in interstate commerce, but engages exclusively in trans-
29 portation or operations excepted by the federal motor carrier
30 safety administration from all or parts of the qualification re-
31 quirements of federal motor carrier safety regulation 49, part
32 391, and is therefore not required to provide a medical examiner's
33 certificate;

34 (iii) Non-excepted intrastate. The applicant operates only in
35 intrastate commerce and is subject to and meets all Idaho driver
36 qualification requirements and the applicable parts of federal
37 motor carrier safety regulation 49, part 391, and is required to
38 provide a medical examiner's certificate; or

39 (iv) Excepted intrastate. The applicant operates in intrastate
40 commerce, but engages exclusively in exempted transportation or
41 operations as listed in section 67-2901B(2), Idaho Code, and the
42 applicable parts of federal motor carrier safety regulation 49,
43 part 391, and is therefore not required to provide a medical exam-
44 iner's certificate.

45 All applications shall also state whether the applicant has previously
46 been licensed as a driver, and if so, when and by what state or country,
47 and whether a driver's license or privileges have ever been suspended,
48 revoked, denied, disqualified, canceled or whether an application has
49 ever been refused, and if so, the date of and reason for the suspension,
50 revocation, denial, disqualification, cancellation or refusal and the

1 applicant's oath that all information is correct as signified by the ap-
2 plicant's signature.

3 (d) The applicant must submit proof of identity and citizenship sta-
4 tus acceptable to the examiner or the department and date of birth as
5 set forth in a certified copy of his birth certificate. When a certified
6 copy of his birth certificate or a delayed birth certificate is impos-
7 sible to obtain from a vital statistics agency, another government-is-
8 sued document listed as acceptable proof of identity pursuant to sec-
9 tion 34-408A(1) (a), Idaho Code, may be submitted that provides satis-
10 factory evidence of a person's full legal name and date of birth accept-
11 able to the examiner or the department.

12 (e) Every applicant for a class A, B or C driver's license or commer-
13 cial learner's permit shall provide proof of United States citizenship
14 with a document listed in section 34-408A(1) (c), Idaho Code, or lawful
15 permanent residency in the United States upon application for issuance,
16 transfer, upgrade or renewal, unless the applicant's driving record al-
17 ready contains documentation confirming United States citizenship or
18 lawful permanent residency. Every applicant for a nondomiciled class
19 A, B or C driver's license or commercial learner's permit domiciled in
20 a foreign country must provide an unexpired employment authorization
21 document issued by the department of homeland security or an unexpired
22 foreign passport accompanied by an approved I-94 form documenting the
23 applicant's most recent admittance into the United States.

24 (f) Individuals required to register in compliance with section 3 of
25 the federal military selective service act, 50 U.S.C. App. 451 et seq.,
26 as amended, shall be provided an opportunity to fulfill such registra-
27 tion requirements in conjunction with an application for a driver's li-
28 cense, commercial learner's permit or instruction permit. Any regis-
29 tration information so supplied shall be transmitted by the department
30 to the selective service system.

31 (4) Whenever an application is received from a person previously li-
32 censed in another jurisdiction, the department shall request a copy of the
33 driver's record from the other jurisdiction and shall contact the national
34 driver register. When received, the driver's record from the previous ju-
35 risdiction shall become a part of the driver's record in this state with the
36 same force and effect as though entered on the driver's record in this state
37 in the original instance.

38 (5) Whenever the department receives a request for a driver's record
39 from another licensing jurisdiction, the record shall be forwarded without
40 charge.

41 (6) The department shall contact and notify the commercial driver li-
42 cense information system of the proposed application for a class A, B or C
43 driver's license or commercial learner's permit to ensure identification of
44 the person and to obtain clearance to issue the license.

45 (7) When the fees required under this section are collected by a county
46 officer, they shall, except as provided in subsection (8) of this section,
47 be paid over to the county treasurer not less often than monthly, who shall

49 (a) Deposit an amount equal to five dollars (\$5.00) from each commer-
50 cial license, ten dollars (\$10.00) from each driver's license except

1 an eight-year class D license, or any class D instruction permit appli-
2 cation fees, application for a duplicate driver's license or permit,
3 classification change, seasonal driver's license and additional en-
4 dorsement, and fifteen dollars (\$15.00) from each eight-year class D
5 driver's license, in the current expense fund;

6 (b) Deposit two dollars and fifty cents (\$2.50) from each motorcycle
7 endorsement and motorcycle endorsement instruction permit fee in the
8 current expense fund;

9 (c) Deposit an amount equal to five dollars (\$5.00) from each fee for a
10 knowledge test in the current expense fund;

11 (d) Deposit an amount up to twenty-five dollars (\$25.00) from each fee
12 for a motorcycle endorsement skills test in the current expense fund;
13 provided however, if a contractor administers the skills test he shall
14 be entitled to the entire fee;

15 (e) Remit the remainder to the state treasurer; and

16 (f) Deposit up to twenty-eight dollars and fifty cents (\$28.50) from
17 each fee for a class D skills test into the county current expense fund,
18 unless the test is administered by a department-approved contractor, in
19 which case the contractor shall be entitled to up to twenty-eight dol-
20 lars and fifty cents (\$28.50) of each fee.

21 (8) When the fees required under this section are collected by the de-
22 partment or an agent authorized by the department, they shall be paid over
23 to the state treasurer. When the department or an agent authorized by the
24 department collects the fees required under this section, the portion of
25 fees to be retained by the county shall be retained by the issuing authorized
26 agent.

27 (9) The state treasurer shall distribute the moneys received from fees
28 imposed by the provisions of this section, whether collected by a county of-
29 ficer or by a state officer or agency as follows:

41 fee for driver's licenses pursuant to subsection (1) (b), (d) and (e) of
42 this section, and one dollar (\$1.00) of each fee charged for driver's
43 licenses pursuant to subsection (1) (c) and (f) of this section shall be
44 deposited in the emergency medical services fund III created in section
45 56-1018B, Idaho Code;

46 (b) Twenty-eight dollars (\$28.00) of each fee for a seasonal or class A,
47 B or C driver's license, and nineteen dollars and fifty cents (\$19.50)
48 of each fee charged for a license pursuant to subsection (1) (b) of this
49 section, and eight dollars and sixteen cents (\$8.16) of each fee charged

1 for a license pursuant to subsection (1) (c) of this section shall be de-
2 posited in the state highway account;

3 (c) Twenty dollars (\$20.00) of each fee for a commercial learner's per-
4 mit or driver's license classification change shall be deposited in the
5 state highway account;

6 (d) Four dollars (\$4.00) of each fee for a commercial learner's permit
7 shall be deposited in the emergency medical services fund III created in
8 section 56-1018B, Idaho Code;

9 (e) Ten dollars (\$10.00) of each fee for a duplicate seasonal or class
10 A, B or C driver's license, class A, B or C driver's license extension,
11 or additional endorsement shall be deposited in the state highway ac-
12 count;

13 (f) Seven dollars and fifty cents (\$7.50) of each fee for a motorcycle
14 endorsement and motorcycle endorsement instruction permit shall be de-
15 posited in the state highway account;

16 (g) Five dollars and thirty cents (\$5.30) of each fee for a four-year
17 class D driver's license, and ten dollars and sixty cents (\$10.60) of
18 each fee for an eight-year class D driver's license, and four dollars
19 (\$4.00) of each fee charged for a license pursuant to subsection (1) (d)
20 and (e) of this section, and one dollar and thirty-three cents (\$1.33)
21 of each fee charged for a license pursuant to subsection (1) (f) of this
22 section shall be deposited in the driver training account;

23 (h) Twelve dollars and seventy cents (\$12.70) of each fee for a
24 four-year class D driver's license, and twenty dollars and forty cents
25 (\$20.40) of each fee for an eight-year class D driver's license, and ten
26 dollars and fifty cents (\$10.50) of each fee charged for a license pur-
27 suant to subsection (1) (d) and (e) of this section, and six dollars and
28 eighty-three cents (\$6.83) of each fee charged for a license pursuant
29 to subsection (1) (f) of this section shall be deposited in the highway
30 distribution account;

31 (i) Two dollars and sixty cents (\$2.60) of each fee for a class D in-
32 struction permit, duplicate class D license or permit, and class D li-
33 cense extension shall be deposited in the driver training account;

34 (j) Seven dollars and forty cents (\$7.40) of each fee for a class D in-
35 struction permit, duplicate class D license or permit, and class D li-
36 cense extension shall be deposited in the highway distribution account;

37 (k) Ten dollars (\$10.00) of each fee for a class A, B or C skills test
38 shall be deposited in the state highway account;

39 (l) One dollar (\$1.00) of each fee for a class A, B, C or four-year D
40 driver's license, and two dollars (\$2.00) of each fee for an eight-year
41 class D driver's license, and one dollar (\$1.00) of each fee charged for
42 a license pursuant to subsection (1) (b), (d) and (e) of this section,
43 and thirty-four cents (34¢) of each fee charged for a license pursuant
44 to subsection (1) (c) and (f) of this section shall be deposited in the
45 motorcycle safety program fund established in section 33-4904, Idaho
46 Code;

47 (m) Six dollars and fifty cents (\$6.50) of each fee for a class D skills
48 test shall be deposited into the state highway account; and

49 (n) Each voluntary contribution of two dollars (\$2.00) as described in
50 subsection (2) of this section, less actual administrative costs asso-

1 ciated with collecting and transferring such contributions, shall be
2 deposited into the organ donation contribution fund created in section
3 49-2447, Idaho Code.

4 (10) The contractor administering a class A, B or C skills test shall
5 be entitled to not more than one hundred ninety dollars (\$190) of the skills
6 test fee. A contractor administering a class A, B or C skills test may col-
7 lect an additional fee for the use of the contractor's vehicle for the skills
8 test.

9 (11) Sixty dollars (\$60.00) of each restricted driving permit and each
10 restricted school attendance driving permit shall be deposited in the state
11 highway account.

12 (12) The department may issue seasonal class B or C driver's licenses to
13 drivers who are employees of agri-chemical businesses, custom harvesters,
14 farm retail outlets and suppliers, and livestock feeders that:

15 (a) Will only be valid for driving commercial vehicles that normally
16 require class B or C commercial driver's licenses;

17 (b) Will be valid for seasonal periods that begin on the date of is-
18 suance and that are not to exceed one hundred eighty (180) days in a
19 twelve (12) month period;

20 (c) May only be obtained twice in a driver's lifetime;

21 (d) Are valid only within a one hundred fifty (150) mile radius of the
22 place of business or farm being serviced; and

23 (e) Will be valid only in conjunction with valid Idaho class D driver's
24 licenses.

25 (13) The department may issue seasonal class B or C driver's licenses to
26 drivers who:

27 (a) Have not violated the single license provisions of applicable fed-
28 eral regulations;

29 (b) Have not had any license suspensions, revocations or cancella-
30 tions;

31 (c) Have not had any convictions in any vehicle for any offense listed
32 in section 49-335(1) or (2), Idaho Code, or any one (1) serious traffic
33 offense;

34 (d) Have at least one (1) year of driving experience with a class D or
35 equivalent license in any type motor vehicle; and

36 (e) Are at least sixteen (16) years old.

37 SECTION 11. That Section 49-315, Idaho Code, be, and the same is hereby
38 amended to read as follows:

39 49-315. LICENSES ISSUED TO DRIVERS. (1) The department shall issue
40 to every qualifying applicant a distinguishing driver's license as applied
41 for, which shall bear a distinguishing number assigned to the licensee, the
42 full name, date of birth, Idaho residence address, sex, weight, height, eye
43 color, hair color, color photograph, name of this state, date of issuance,
44 date of expiration, license class, endorsements, restrictions, and the ap-
45 plicant's signature. If an applicant has submitted an application pursuant
46 to the provisions of chapter 58, title 19, Idaho Code, then the applicant's
47 driver's license shall contain his or her alternative Idaho mailing address
48 in place of his or her Idaho residence address. Driver's licenses for per-

2 years of age to twenty-one (21) years of age shall include a notation "under
3 21 until (month, day, year)." No driver's license shall be valid until it has
4 been signed on the signature line of the license by the licensee. Driver's
5 licenses for persons who are United States citizens may include the notation
6 "USA."

7 (2) Every driver's license shall bear a color photograph of the li-
8 censee, which shall be taken by the examiner at the time the application is
9 made. The photograph shall be taken without headgear or other clothing or
10 device that disguises or otherwise conceals the face or head of the appli-
11 cant. A waiver may be granted by the department allowing the applicant to
12 wear headgear or other head covering for medical, religious or safety pur-
13 poses as long as the face is not disguised or otherwise concealed. At the
14 request of the applicant, a driver's license may contain a statement or indi-
15 cation of the medical condition of the licensee.

16 (3) The department shall notify the commercial driver license infor-
17 mation system that a class A, B or C driver's license has been issued as re-
18 quired by 49 CFR parts 383 and 384.

19 (4) A licensee applying for a hazardous material endorsement on a
20 driver's license shall have a security background records check and shall
21 receive clearance from the federal transportation security administration
22 before the endorsement can be issued, renewed or transferred as required
23 by 49 CFR part 383, subject to procedures established by the federal trans-
24 portation security administration.

25 (5) A licensee who desires to donate any or all organs or tissue in the
26 event of death, and who has completed a document of gift pursuant to the pro-
27 visions for donation of anatomical gifts as set forth in chapter 34, title
28 39, Idaho Code, may, at the option of the donor, indicate this desire on the
29 driver's license by the imprinting of the word "donor" on the license. The
30 provisions of this subsection shall apply to licensees fifteen (15) years of
31 age or older but less than eighteen (18) years of age if the requirements pro-
32 vided in chapter 34, title 39, Idaho Code, have been complied with and the
33 donor indicates this desire be placed on the license.

34 (6) A licensee who is a person with a permanent disability may request
35 that the notation "permanently disabled" be imprinted on the driver's li-
36 cense, provided the licensee presents written certification from a licensed
37 physician verifying that the licensee's stated impairment qualifies as a
38 permanent disability according to the provisions of section 49-117, Idaho
39 Code.

40 (7) (a) A licensee who is a veteran may request that his or her status as
41 such be designated on the driver's license at no additional cost. Any
42 such request shall be accompanied by proof of being a current or former
43 member of the United States armed forces. Upon request and submission
44 of satisfactory proof, the department shall indicate such person's statu-
45 s as a veteran on any class of driver's license issued pursuant to this
46 section. Such designation shall be made upon original issuance or re-
47 newal of a driver's license. Designation shall also be made on any du-
48 plicate driver's license issued, provided that the fee for such dupli-
49 cate driver's license is paid in accordance with section 49-306, Idaho
50 Code.

1 **(b)** Satisfactory proof of being a current or former member of the United
2 States armed forces must be furnished by an applicant to the department
3 before a designation of veteran status will be indicated on any class
4 of driver's license. Acceptable proof shall be a copy of form DD214 or
5 an equivalent document or statement from the department of veterans af-
6 fairs that identifies a character of service upon separation as "honor-
7 able" or "general under honorable conditions."

8 SECTION 12. That Section 49-321, Idaho Code, be, and the same is hereby
9 amended to read as follows:

10 49-321. RECORDS TO BE KEPT BY THE DEPARTMENT. (1) The department shall
11 file every application for a driver's license received by it and shall main-
12 tain suitable indices containing:

- 13 (a) All applications denied and on each note the reason for denial;
14 (b) All applications granted;
15 (c) The name of every licensee whose driver's license has been sus-

33 electronic form. The department shall maintain convenient records or make
34 suitable notations in order that an individual record of each licensee show-

35 Any registration information so supplied shall be transmitted by the depart-
36 ment to the selective service system.

37 (25) Every identification card, except those issued to persons under
38 twenty-one (21) years of age, shall be renewable on or before its expiration,
39 but not more than twenty-five (25) months before, and upon application and
40 payment of the required fee.

41 (36) The applicant for an identification card must submit proof of
42 identity, citizenship status, and date of birth as set forth in a certified
43 copy of his birth certificate. When a certified copy of his birth certifi-
44 cate or a delayed birth certificate is impossible to obtain from a vital
45 statistics agency, another government-issued document as set forth in sec-
46 tion 34-408A(1) (c), Idaho Code, may be accepted as proof of a person's full

48 (7) (a) Every identification card issued to a person who is a citizen of

4 as indicated on documents issued and verified by the department of home-

42 **(711)** A person possessing an identification card who desires to donate
43 any or all organs or tissue in the event of death, and who has completed a
44 document of gift pursuant to the provisions for donation of anatomical gifts
45 as set forth in chapter 34, title 39, Idaho Code, may, at the option of the
46 donor, indicate this desire on the identification card by the imprinting of
47 the word "donor" on the identification card. The provisions of this subsec-
48 tion shall apply to persons possessing an identification card who are fif-
49 teen (15) years of age or older but less than eighteen (18) years of age if

1 the requirements provided in chapter 34, title 39, Idaho Code, have been com-
2 plied with.

3 (~~8~~12) A person possessing an identification card or an applicant for an
4 identification card who is a person with a permanent disability may request
5 that the notation "permanently disabled" be imprinted on the identification
6 card, provided the person presents written certification from a licensed
7 physician verifying that the person's stated impairment qualifies as a per-
8 manent disability according to the provisions of section 49-117, Idaho Code.

9 ~~(9)~~ (13) (a) A person who is a veteran may request that his or her status
10 as such be designated on an identification card at no additional cost.
11 Any such request shall be accompanied by proof of being a current or for-
12 mer member of the United States armed forces. Upon request and submis-
13 sion of satisfactory proof, the department shall indicate such person's
14 status as a veteran on any identification card issued pursuant to the
15 provisions of this section. Such designation shall be made upon origi-
16 nal issuance or renewal of an identification card. Designation shall
17 also be made on any duplicate identification card issued, provided that
18 the fee for such duplicate card is paid in accordance with this section.

19 (b) Satisfactory proof of being a current or former member of the United
20 States armed forces must be furnished by an applicant to the depart-

22 identification card. Acceptable proof shall be a copy of form DD214
23 or an equivalent document or statement from the department of veterans
24 affairs that identifies a character of service upon separation as "hon-
25 orable" or "general under honorable conditions."

26 (104) In the case of a name change, the applicant shall provide legal
27 documentation to verify the change in accordance with department rules.

28 (115) Whenever any person, after applying for or receiving an identifi-
29 cation card, shall move from the address shown on the application or on the
30 identification card issued, that person shall, within thirty (30) days, no-
31 tify the transportation department in writing of the old and new addresses.

32 (126) The department shall cancel any identification card upon deter-
33 mining that the person was not entitled to the issuance of the identification
34 card or that the person failed to give the required and correct information
35 in his application or committed fraud in making the application. Upon can-
36 cellation, the person shall surrender the canceled identification card to
37 the department.

38 (137) If any person shall fail to return to the department the identifi-
39 cation card as required, the department may direct any peace officer to se-
40 cure its possession and return the identification card to the department.

41 (148) The department may issue a no-fee identification card to an indi-
42 vidual whose driver's license has been canceled and voluntarily surrendered
43 as provided in section 49-322 (5), Idaho Code. The identification card may be
44 renewed at no cost to the applicant as long as the driver's license remains
45 canceled.

46 (159) It is an infraction for any person to fail to notify the department
47 of a change of address as required by the provisions of subsection (145) of
48 this section.

49 SECTION 14. SEVERABILITY. The provisions of this act are hereby de-
50 clared to be severable, and if any provision of this act or the application

1 of such provision to any person or circumstance is declared invalid for any
2 reason, such declaration shall not affect the validity of the remaining por-
3 tions of this act.

4 SECTION 15. An emergency existing therefor, which emergency is hereby
5 declared to exist, this act shall be in full force and effect on and after its
6 passage and approval.
