1 2 3 4 5 6 7 8	AN ACT RELATING TO IMMUNIZATION; AMENDING CHAPTER 23, TITLE 67, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 67-2359, IDAHO CODE, TO PROVIDE THAT A PERSON SHALL NOT BE REQUIRED TO RECEIVE A CORONAVIRUS VACCINATION, HAVE A VAC- CINE PASSPORT, OR PROVIDE PROOF OF ANY OTHER FORM OF CORONAVIRUS IMMU- NIZATION OR NEGATIVE LABORATORY TEST FOR CERTAIN PURPOSES, TO PROHIBIT CERTAIN DISCRIMINATION, TO DEFINE TERMS, AND TO PROVIDE FOR CERTAIN EX- CEPTIONS; PROVIDING SEVERABILITY; AND DECLARING AN EMERGENCY.
9	Be It Enacted by the Legislature of the State of Idaho:
10 11 12	SECTION 1. That Chapter 23, Title 67, Idaho Code, be, and the same is hereby amended by the addition thereto of a $\underline{\text{NEW SECTION}}$, to be known and designated as Section 67-2359, Idaho Code, and to read as follows:
13 14 15 16 17	67-2359. CORONAVIRUS VACCINE PASSPORTS PROHIBITED. (1) No person shall be required to receive a coronavirus vaccination, have a vaccine passport, or provide proof of any other form of coronavirus immunization or negative laboratory test result for coronavirus in order to: (a) Apply for or receive services provided by the state or a political subdivision of the state;
19 20	(b) Enter or remain in a government venue during a time when the venue is accessible to the general public; or
21 22 23 24 25	(c) Be hired by the state or maintain employment with the state. An employee of the state or a political subdivision of the state may not be discriminated against on the basis of such employee's immunization status, including decisions relating to promotion, compensation, or job duties. However, the state may require:
26 27 28	 (i) An employee who has previously tested positive for coron- avirus to provide a negative laboratory test result for coron- avirus in order to return to work;
29 30 31	(ii) An employee to be tested for coronavirus if the employee was potentially exposed to coronavirus during the course and scope of employment; or
32 33	(iii) Coronavirus vaccination for an employee whose job duties include:

- (a) "Coronavirus" means:

- (i) Severe acute respiratory syndrome coronavirus 2;
- (ii) The disease caused by severe acute respiratory syndrome coronavirus 2; or

- (iii) Any subsequently identified mutation, modification, or strain of coronavirus if the transmission of said virus among humans rises to the level of an epidemic or pandemic and qualifies for an emergency declaration under applicable Idaho law.
- (b) "Government venue" means a building, an office, a school, a park, a recreation area, or any other place that:
 - (i) Is owned or operated by the state or a political subdivision of the state; and
 - (ii) Is:

- 1. Accessible to the general public during the day or part of the day; or
- 2. A place where people apply for or receive services offered by the state or a political subdivision of the state.
- (c) "Immunization status" means an indication of whether a person has received one (1) or more doses of a vaccine for coronavirus.
- (d) "Political subdivision" means a city, a county, a school district, a special purpose district, a community college, a public body corporate and politic, or any other entity created by state law, local ordinance, or executive order.
- (e) "State" means any agency, officer, department, division, bureau, board, commission, or institution of the state of Idaho, including any state institution of higher education.
- (f) "Vaccine passport" means a document establishing that a person has been vaccinated for coronavirus.
- (3) This section does not apply to any coronavirus immunization requirement:
 - (a) Imposed by the federal government;
 - (b) For schools pursuant to chapter 48, title 39, Idaho Code;
 - (c) For day care facilities pursuant to chapter 11, title 39, Idaho Code; or
 - (d) Imposed by a health care facility as defined in section 48-303, Idaho Code.
- SECTION 2. SEVERABILITY. The provisions of this act are hereby declared to be severable, and if any provision of this act or the application of such provision to any person or circumstance is declared invalid for any reason, such declaration shall not affect the validity of the remaining portions of this act.
- SECTION 3. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after its passage and approval.
