8 9 10	SECTION 1. That Chapter 23, Title 67, Idaho Code, be, and the same is hereby amended by the addition thereto of a NEW SECTION , to be known and designated as Section 67-2359, Idaho Code, and to read as follows:
11 12 13 14 15	67-2359. NOTIFICATION OF REFUGEE RESETTLEMENT. (1) A nongovernmental organization (NGO) assisting in the resettlement of refugees in Idaho shall, as soon as practicable, notify the following that a refugee has or will be resettled in Idaho: (a) The governor;
16 17 18 19	 (a) The governor, (b) The director of the department of labor; (c) The director of the department of health and welfare; (d) The board of county commissioners of the county in which the refugee has or will be resettled; and
20 21	(e) As applicable, the mayor of the city in which the refugee has or will be resettled.
22 23	(2) The notification required by subsection (1) of this section shall include the refugee's name, age, sex, country of origin, and reason for re-
24 25 26	(3) An NGO that fails to abide by the provisions of this section shall not be eligible for a tax exemption for which it otherwise qualifies under
27	chapter 6, title 63, Idaho Code.

- (a) "Nongovernmental organization" or "NGO" means a corporation, a company, a partnership, an association, a trust, a foundation, a fund, or another entity or group of persons, whether or not incorporated, permanently or temporarily associated together with joint action on any subject or subjects. The term "nongovernmental organization" shall not include:
 - (i) The federal government;
 - (ii) The government of any state or district in the United States;
 - (iii) The government of any territory of the United States; or
 - (iv) Any political subdivision or independent public body corporate and politic of:
 - 1. A state or district in the United States; or
 - 2. A territory of the United States.
- (b) "Refugee" shall have the same meaning as provided in 8 U.S.C. 1101.

SECTION 2. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after its passage and approval.
