AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR
2 FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF
3 HEALTH AND WELFARE FOR STATE HOSPITAL NORTH FOR FISCAL YEAR 2023; REDUC-
4 ING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR STATE
5 HOSPITAL NORTH FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO
6 THE DEPARTMENT OF HEALTH AND WELFARE FOR STATE HOSPITAL WEST FOR FISCAL
7 YEAR 2023; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND
8 WELFARE FOR STATE HOSPITAL WEST FOR FISCAL YEAR 2023; APPROPRIATING AD-
9 DITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR STATE HOS-
10 PITAL SOUTH FOR FISCAL YEAR 2023; REDUCING THE APPROPRIATION TO THE DE-
11 PARTMENT OF HEALTH AND WELFARE FOR STATE HOSPITAL SOUTH FOR FISCAL YEAR
12 2023; AND DECLARING AN EMERGENCY.

14 Be It Enacted by the Legislature of the State of Idaho:

15 SECTION 1. In addition to the appropriation made in Section 1, Chap-
16 ter 127, Laws of 2022, and any other appropriation provided by law, there
17 is hereby appropriated to the Division of Psychiatric Hospitalization for
18 State Hospital North \$1,700,000 from the Cooperative Welfare (General) Fund
19 to be expended for personnel costs for the period July 1, 2022, through June
20 30, 2023.

21 SECTION 2. Notwithstanding any other provision of law to the contrary,
22 the appropriation made to the Division of Psychiatric Hospitalization for
23 State Hospital North in Section 1, Chapter 127, Laws of 2022, from the Coop-
24 erative Welfare (Federal) Fund is hereby reduced by \$1,700,000 for personnel
25 costs for the period July 1, 2022, through June 30, 2023.

26 SECTION 3. In addition to the appropriation made in Section 1, Chap-
27 ter 127, Laws of 2022, and any other appropriation provided by law, there
28 is hereby appropriated to the Division of Psychiatric Hospitalization for
29 State Hospital West \$1,800,000 from the Cooperative Welfare (General) Fund
30 to be expended for personnel costs for the period July 1, 2022, through June
31 30, 2023.

32 SECTION 4. Notwithstanding any other provision of law to the contrary,
33 the appropriation made to the Division of Psychiatric Hospitalization for
34 State Hospital West in Section 1, Chapter 127, Laws of 2022, from the Coop-
35 erative Welfare (Federal) Fund is hereby reduced by \$1,800,000 for personnel
36 costs for the period July 1, 2022, through June 30, 2023.

37 SECTION 5. In addition to the appropriation made in Section 1, Chap-
38 ter 127, Laws of 2022, and any other appropriation provided by law, there
39 is hereby appropriated to the Division of Psychiatric Hospitalization for

1 State Hospital South the following amounts to be expended for personnel
2 costs from the listed funds for the period July 1, 2022, through June 30,
3 2023:

8 SECTION 6. Notwithstanding any other provision of law to the contrary,
9 the appropriation made to the Division of Psychiatric Hospitalization for
10 State Hospital South in Section 1, Chapter 127, Laws of 2022, from the Coop-
11 erative Welfare (Federal) Fund is hereby reduced by \$1,600,000 for personnel
12 costs for the period July 1, 2022, through June 30, 2023.

13 SECTION 7. An emergency existing therefor, which emergency is hereby
14 declared to exist, this act shall be in full force and effect on and after its
15 passage and approval.
