SENATE BILL NO. 1139

 2 RELATING TO THE APPROPRIATION TO THE EXECUTIVE OFFICE OF THE GOVERNOR FOR
 3 FISCAL YEAR 2024; APPROPRIATING MONEYS TO THE EXECUTIVE OFFICE OF THE
 4 GOVERNOR FOR FISCAL YEAR 2024; LIMITING THE NUMBER OF AUTHORIZED FULL-
 5 TIME EQUIVALENT POSITIONS; EXEMPTING THE APPROPRIATION FROM OBJECT AND
 6 PROGRAM TRANSFER LIMITATIONS; AND DECLARING AN EMERGENCY AND PROVIDING
 7 AN EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the Executive Office of the
 10 Governor the following amounts to be expended according to the designated
 11 programs and expense classes from the listed funds for the period July 1,
 12 2023, through June 30, 2024:

1 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
2 Idaho Code, the Executive Office of the Governor is authorized no more than
3 twenty-one (21.00) full-time equivalent positions at any point during the
4 period July 1, 2023, through June 30, 2024, unless specifically authorized
5 by the Governor. The Joint Finance-Appropriations Committee will be noti-
6 fied promptly of any increased positions so authorized.

7 SECTION 3. EXEMPTIONS FROM OBJECT AND PROGRAM TRANSFER LIMITATIONS.
8 For fiscal year 2024, the Executive Office of the Governor is hereby exempted
9 from the provisions of Section 67-3511 (1), (2), and (3), Idaho Code, allow-
10 ing unlimited transfers between object codes and between programs, for all
11 moneys appropriated to it for the period July 1, 2023, through June 30, 2024.
12 Legislative appropriations shall not be transferred from one fund to another
13 fund unless expressly approved by the Legislature.

14 SECTION 4. An emergency existing therefor, which emergency is hereby
15 declared to exist, this act shall be in full force and effect on and after
16 July 1, 2023.
