SENATE BILL NO. 1182

AN ACT

1 RELATING TO THE IDAHO UNIFORM BUSINESS ORGANIZATIONS CODE; AMENDING SEC-  
2 TION 30-30-1201, IDAHO CODE, AS ADDED IN SECTION 85 OF SENATE BILL NO.  
3 1025, AS ENACTED BY THE FIRST REGULAR SESSION OF THE SIXTY-THIRD IDAHO  
4 LEGISLATURE, TO REVISE THE DATE OF APPLICABILITY; AMENDING SECTION  
5 30-30-1202, IDAHO CODE, AS ADDED IN SECTION 85 OF SENATE BILL NO. 1025,  
6 AS ENACTED BY THE FIRST REGULAR SESSION OF THE SIXTY-THIRD IDAHO LEGIS-  
7 LATURE, TO REVISE THE DATE OF APPLICABILITY; REPEALING CHAPTER 3, TITLE  
8 30, IDAHO CODE, RELATING TO THE IDAHO NONPROFIT CORPORATION ACT; AND  
9 PROVIDING EFFECTIVE DATES.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. That Section 30-30-1201, Idaho Code, as added in Section  
13 85 of Senate Bill No. 1025, as enacted by the First Regular Session of the  
14 Sixty-third Idaho Legislature, be, and the same is hereby amended to read as  
15 follows:

16 30-30-1201. APPLICATION TO EXISTING DOMESTIC NONPROFIT CORPORA-  
17 TIONS. This chapter applies to all domestic nonprofit corporations in  
18 existence on July 1, ~~1993~~ 2015, that were incorporated under the laws of this  
19 state.

20 SECTION 2. That Section 30-30-1202, Idaho Code, as added in Section  
21 85 of Senate Bill No. 1025, as enacted by the First Regular Session of the  
22 Sixty-third Idaho Legislature, be, and the same is hereby amended to read as  
23 follows:

24 30-30-1202. APPLICATION TO QUALIFIED FOREIGN NONPROFIT CORPORA-  
25 TION. A foreign nonprofit corporation authorized to transact business in  
26 this state on July 1, ~~1993~~ 2015, is subject to this chapter but is not re-  
27 quired to obtain a new certificate of authority to transact business under  
28 this chapter.

29 SECTION 3. That Chapter 3, Title 30, Idaho Code, be, and the same is  
30 hereby repealed.

31 SECTION 4. The provisions of Sections 2, 4 and 5 of Senate Bill No.  
32 1025, as enacted by the First Regular Session of the Sixty-third Idaho Legis-  
33 lature, shall be in full force and effect on and after July 1, 2017.
