5	PROVIDING FOR THE RETURN OF UNUSED MONEYS; EXEMPTING THE APPROPRIATION
7	FROM OBJECT TRANSFER LIMITATIONS; AND DECLARING AN EMERGENCY.

- 8 Be It Enacted by the Legislature of the State of Idaho:
- 9 SECTION 1. There is hereby appropriated and the State Controller shall 10 transfer \$529,000 from the General Fund to the Permanent Building Fund as 11 soon as practicable.
 - SECTION 2. In addition to the appropriation made in Section 1, Chapter 302, Laws of 2018, and any other appropriation provided by law, there is hereby appropriated to the Department of Administration for the Division of Public Works \$529,000 from the Permanent Building Fund for the period July 1, 2018, through June 30, 2019, for the purpose of the necessary renovation costs of the Borah Building or for other reasonable office space for the State Treasurer, for associated moving costs to relocate all, or part of, the office of the State Treasurer, and for any necessary capital outlay for computer or office equipment.
 - SECTION 3. RETURN OF UNUSED MONEYS. Notwithstanding the provisions of Section 5, Chapter 302, Laws of 2018, and any other provision of law to the contrary, of the amount appropriated in Section 2 of this act, the Division of Public Works shall notify the State Controller of any unexpended and unencumbered moneys upon completion of the project and the State Controller shall transfer such moneys from the Permanent Building Fund to the General Fund as soon as practicable.
 - SECTION 4. EXEMPTIONS FROM OBJECT TRANSFER LIMITATIONS. The amount appropriated in Section 2 of this act is hereby exempted from the provisions of Section 67--3511(1) and (3), Idaho Code, allowing unlimited transfers between object codes. Legislative appropriations shall not be transferred from one fund to another fund unless expressly approved by the Legislature.
 - SECTION 5. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after its passage and approval.
