AN ACT

1 RELATING TO THE APPROPRIATION TO THE SUPREME COURT FOR FISCAL YEAR 2019;  
2 APPROPRIATING ADDITIONAL MONEYS TO THE SUPREME COURT FOR THE SUPREME  
3 COURT PROGRAM FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO  
4 THE SUPREME COURT FOR THE COURT OF APPEALS PROGRAM FOR FISCAL YEAR 2019;  
5 APPROPRIATING ADDITIONAL MONEYS TO THE SUPREME COURT FOR THE DISTRICT  
6 COURTS PROGRAM FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO  
7 THE SUPREME COURT FOR THE MAGISTRATE DIVISION PROGRAM FOR FISCAL YEAR  
8 2019; AND EXEMPTING THE SUPREME COURT'S APPROPRIATION FROM OBJECT AND  
9 PROGRAM TRANSFER LIMITATIONS.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. In addition to any other appropriation provided by law,  
13 there is hereby appropriated to the Supreme Court for the Supreme Court Pro-  
14 gram \$38,900 from the General Fund to be expended for personnel costs for  
15 the period July 1, 2018, through June 30, 2019, for the purpose of judicial  
16 salaries.

17 SECTION 2. In addition to any other appropriation provided by law,  
18 there is hereby appropriated to the Supreme Court for the Court of Appeals  
19 Program \$24,500 from the General Fund to be expended for personnel costs for  
20 the period July 1, 2018, through June 30, 2019, for the purpose of judicial  
21 salaries.

22 SECTION 3. In addition to any other appropriation provided by law,  
23 there is hereby appropriated to the Supreme Court for the District Courts  
24 Program \$275,800 from the General Fund to be expended for personnel costs for  
25 the period July 1, 2018, through June 30, 2019, for the purpose of judicial  
26 salaries.

27 SECTION 4. In addition to any other appropriation provided by law,  
28 there is hereby appropriated to the Supreme Court for the Magistrate Divi-  
29 sion Program \$417,300 from the General Fund to be expended for personnel  
30 costs for the period July 1, 2018, through June 30, 2019, for the purpose of  
31 judicial salaries.

32 SECTION 5. EXEMPTIONS FROM OBJECT AND PROGRAM TRANSFER LIMITATIONS.  
33 For fiscal year 2019, the Supreme Court is hereby exempted from the provi-  
34 sions of Section 67-3511(1), (2) and (3), Idaho Code, allowing unlimited  
35 transfers between object codes and between programs for all moneys appropri-  
36 ated to it for the period July 1, 2018, through June 30, 2019. Legislative  
37 appropriations shall not be transferred from one fund to another fund unless  
38 expressly approved by the Legislature.
