1 RELATING TO APPROPRIATIONS AND TRANSFERS OF IDAHO MILLENNIUM FUNDS; AP-
2 PROPRIATING AND TRANSFERRING MONEYS FROM THE IDAHO MILLENNIUM FUND TO
3 THE IDAHO MILLENNIUM PERMANENT ENDOWMENT FUND FOR FISCAL YEAR 2012;
4 APPROPRIATING AND TRANSFERRING MONEYS FROM THE IDAHO MILLENNIUM FUND
5 TO THE IDAHO MILLENNIUM INCOME FUND FOR FISCAL YEAR 2012; APPROPRIATING
6 ADDITIONAL MONEYS TO THE STATE TREASURER FOR FISCAL YEAR 2012; APPRO-
7 PRIATING MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE COMMUNITY-BASED

16 TO THE STATE TREASURER FOR DISTRIBUTION TO THE BOYS AND GIRLS CLUBS OF
17 IDAHO FOR FISCAL YEAR 2013; APPROPRIATING MONEYS TO THE STATE TREASURER
18 FOR DISTRIBUTION TO THE IDAHO METH PROJECT FOR FISCAL YEAR 2013; APPRO-
19 PRIATING MONEYS TO THE STATE TREASURER FOR DISTRIBUTION TO THE IDAHO
20 DRUG FREE YOUTH PROGRAM FOR FISCAL YEAR 2013; APPROPRIATING MONEYS TO
21 THE PUBLIC HEALTH DISTRICTS FOR THE PUBLIC HEALTH DISTRICT MILLENNIUM
22 FUND CESSATION PROGRAM FOR FISCAL YEAR 2013; APPROPRIATING MONEYS TO
23 THE DEPARTMENT OF HEALTH AND WELFARE FOR THE PHYSICAL HEALTH SERVICES
24 PROGRAM FOR FISCAL YEAR 2013; APPROPRIATING MONEYS TO THE IDAHO STATE
25 POLICE FOR TOBACCO PERMITTEE COMPLIANCE INSPECTIONS FOR FISCAL YEAR
26 2013; PROVIDING THAT CERTAIN UNEXPENDED AND UNENCUMBERED MONEYS SHALL
27 REVERT TO THE IDAHO MILLENNIUM INCOME FUND AT THE END OF FISCAL YEAR
28 2013; AND DECLARING AN EMERGENCY.

30 Be It Enacted by the Legislature of the State of Idaho:

31 SECTION 1. There is hereby appropriated and the State Controller shall
32 transfer \$161,000 from the Idaho Millennium Fund to the Idaho Millennium
33 Permanent Endowment Fund for the period July 1, 2011, through June 30, 2012,
34 for the purpose of repaying prior year investment management consulting fees
35 that were paid in error from the Idaho Millennium Permanent Endowment Fund
36 from fiscal year 2009 through fiscal year 2011.

37 SECTION 2. There is hereby appropriated and the State Controller shall
38 transfer \$80,000 from the Idaho Millennium Fund to the Idaho Millennium In-
39 come Fund for the period July 1, 2011, through June 30, 2012.

40 SECTION 3. In addition to the appropriation made in Section 1, Chap-
41 ter 290, Laws of 2011, and any other appropriation provided for by law, there

1 is hereby appropriated \$80,000 from the Idaho Millennium Income Fund to the
2 State Treasurer, to be expended for operating expenditures, for the period
3 July 1, 2011, through June 30, 2012.

4 SECTION 4. There is hereby appropriated, and at the request of the
5 State Treasurer, the State Controller shall transfer \$1,859,200 from the
6 Idaho Millennium Income Fund to the Department of Correction for the Commu-
7 nity-Based Substance Abuse Treatment Services program, to be expended for
8 trustee and benefit payments, for the period July 1, 2012, through June 30,
9 2013. The purpose of this grant is to continue coordination, assessment and
10 community-based substance abuse treatment and recovery support services for
11 felony offenders, in lieu of incarceration in a state facility.

12 SECTION 5. There is hereby appropriated, and at the request of the State
13 Treasurer, the State Controller shall transfer \$450,000 from the Idaho Mil-
14 lennium Income Fund to the Supreme Court for the Community-Based Substance
15 Abuse Treatment Services program for the period July 1, 2012, through June
16 30, 2013. The purpose of this grant is to support youth courts as a juvenile
17 prevention and intervention program, programs for tobacco and substance
18 abuse status offenders, and tobacco and alcohol diversion courts to handle
19 underage misdemeanor tobacco and alcohol cases.

20 SECTION 6. There is hereby appropriated \$120,700 from the Idaho Mil-
21 lennium Income Fund to the State Treasurer for distribution to the Ameri-
22 can Lung Association for the period July 1, 2012, through June 30, 2013. The
23 purpose of this grant is to help the American Lung Association deliver three
24 programs to address youth tobacco prevention, engagement and smoking cessa-
25 tion: Teens Against Tobacco Use (TATU), Support Teens Against Nicotine De-
26 pendency (STAND) and Not On Tobacco (N-O-T).

27 SECTION 7. On behalf of the American Cancer Society, Cancer Action
28 Network, there is hereby appropriated and, at the request of the State
29 Treasurer, the State Controller shall transfer \$250,000 from the Idaho Mil-
30 lennium Income Fund to the Department of Health and Welfare for the Division
31 of Public Health, Bureau of Clinical and Preventive Services, for the period
32 July 1, 2012, through June 30, 2013. The purpose of this grant is to support
33 breast and cervical cancer early detection efforts of the Idaho Women's
34 Health Check program for qualifying low-income, uninsured or underinsured
35 women. It will also be used to assess tobacco use history of all enrolled
36 clients, referring those who use tobacco to Idaho's QuitLine, QuitNet or
37 other tobacco cessation resources.

38 SECTION 8. There is hereby appropriated \$113,000 from the Idaho Millen-
39 nium Income Fund to the State Treasurer, for distribution to the Allumbaugh
40 House partnership for the period July 1, 2012, through June 30, 2013. The
41 purpose of this grant is to sustain sobering, detoxification and crisis men-
42 tal health services and financial commitments from state and local govern-
43 ment and private partners for fiscal year 2013.

1 SECTION 9. There is hereby appropriated \$177,500 from the Idaho Mil-
2 lennium Income Fund to the State Treasurer for distribution to the Boys and
3 Girls Clubs of Idaho for the period July 1, 2012, through June 30, 2013. The
4 purpose of this grant is to launch a statewide methamphetamine education and
5 prevention program, known as MethSMART, and to expand the current SMARTMoves
6 series to serve additional youth. The objective of these two programs is to
7 prevent or delay the onset of meth, tobacco, alcohol, and other drug use and
8 sexual involvement by young people.

9 SECTION 10. There is hereby appropriated \$100,000 from the Idaho Mil-
10 lennium Income Fund to the State Treasurer for distribution to the Idaho Meth
11 Project for the period July 1, 2012, through June 30, 2013. The purpose of
12 this grant is to provide the resources necessary to leverage private sector
13 funding and media match to support a statewide media campaign aimed at sig-
14 nificantly reducing first-time meth use.

15 SECTION 11. There is hereby appropriated \$150,000 from the Idaho Mil-
16 lennium Income Fund to the State Treasurer for distribution to the Idaho Drug
17 Free Youth program for the period July 1, 2012, through June 30, 2013. The
18 purpose of this grant is to implement a multifaceted parent and teen preven-
19 tion education program called i2i to educate Idaho parents, together with
20 their teens, about alcohol and other drugs and the damage that substances can
21 do to the underdeveloped teen brain.

22 SECTION 12. There is hereby appropriated, and at the request of the
23 State Treasurer, the State Controller shall transfer \$400,000 from the Idaho
24 Millennium Income Fund to the Public Health Districts for the period July 1,
25 2012, through June 30, 2013. The purpose of this grant is to continue the
26 Public Health District Millennium Fund cessation program. Through this pro-
27 gram, high-quality, best practice tobacco cessation programs are provided
28 statewide at no cost to Idahoans who want to quit smoking, with a primary
29 emphasis on youth and pregnant women.

30 SECTION 13. There is hereby appropriated, and at the request of the
31 State Treasurer, the State Controller shall transfer \$2,000,000 from the
32 Idaho Millennium Income Fund to the Department of Health and Welfare for the
33 Physical Health Services program for the period July 1, 2012, through June
34 30, 2013. The purpose of this grant is to support Project Filter tobacco
35 prevention and control programs, counter-marketing, QuitNet and QuitLine
36 tobacco cessation programs, and nicotine replacement therapy. These funds
37 shall not be used for local programs identified in the department's applica-
38 tion proposal, since they may duplicate other programs funded from the Idaho
39 Millennium Income Fund.

40 SECTION 14. There is hereby appropriated, and at the request of the
41 State Treasurer, the State Controller shall transfer \$94,000 from the Idaho
42 Millennium Income Fund to the Idaho State Police for Law Enforcement pro-
43 grams to be expended for the period July 1, 2012, through June 30, 2013. The
44 purpose of this grant is to assist the Idaho State Police and the Department

1 of Health and Welfare with the cost of tobacco permittee compliance inspec-
2 tions as required by law.

3 SECTION 15. Notwithstanding any other provision of law to the contrary,
4 on June 30, 2013, or as soon thereafter as is practicable, any remaining un-
5 expended and unencumbered balance of moneys appropriated in Sections 4, 5,
6 7, 12, 13 and 14 of this act, shall be reverted to the Idaho Millennium Income
7 Fund.

8 SECTION 16. An emergency existing therefor, which emergency is hereby
9 declared to exist, Sections 1, 2 and 3 of this act shall be in full force and
10 effect on and after passage and approval.
