AN ACT

REDUCING THE APPROPRIATION TO THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO AND THE STATE BOARD OF EDUCATION FOR HEALTH EDUCATION PROGRAMS FOR FISCAL YEAR 2010; APPROPRIATING ADDITIONAL MONEYS TO THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO AND THE STATE BOARD OF EDUCATION FOR HEALTH EDUCATION PROGRAMS FOR FISCAL YEAR 2010; APPROPRIATING MONEYS TO THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO AND THE STATE BOARD OF EDUCATION FOR HEALTH EDUCATION PROGRAMS FOR FISCAL YEAR 2011; LIMITING THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; REAPPROPRIATING CERTAIN UNEXPENDED AND UNENCUMBERED BALANCES FOR THE SEVERAL DESIGNATED PROGRAMS; EXEMPTING THE BOARD FROM CERTAIN APPROPRIATION TRANSFER LIMITATIONS; PROVIDING LEGISLATIVE INTENT REGARDING HEALTH EDUCATION STUDENT SEATS; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. Notwithstanding any other provision of law to the contrary, the appropriation made in Section 1, Chapter 253, Laws of 2009, to the Board of Regents of the University of Idaho and the State Board of Education for Health Education Programs is hereby reduced by the following amount for the designated programs according to the designated expense classes from the listed fund for the period July 1, 2009, through June 30, 2010:

29 SECTION 4. In accordance with Section 67-3519, Idaho Code, there is au-  
30 thorized no more than twenty and fifty hundredths (20.50) full-time equiva-  
31 lent positions at any point during the period July 1, 2010, through June 30,  
32 2011, for the W-I Veterinary Education Program, WWAMI Medical Education Pro-  
33 gram, Idaho Dental Education Program and Family Practice Residencies Pro-  
34 gram as specified in Section 3 of this act, unless specifically authorized by  
35 the Governor. The Joint Finance-Appropriations Committee will be notified  
36 promptly of any increased positions so authorized.

37 SECTION 5. There is hereby reappropriated to the Board of Regents of the  
38 University of Idaho and the State Board of Education for the W-I Veterinary  
39 Education Program, WWAMI Medical Education Program, Idaho Dental Education  
40 Program, University of Utah Medical Education Program, Family Medicine Res-

1 residency Programs, the WICHE Program and the Psychiatry Residency Program the  
2 unexpended and unencumbered balance of any non-General Fund appropriation  
3 contained in Section 1, Chapter 253, Laws of 2009, to be used for nonrecur-  
4 ring expenditures, for the period July 1, 2010, through June 30, 2011.

5 SECTION 6. EXEMPTIONS FROM CERTAIN APPROPRIATION TRANSFER LIMITA-  
6 TIONS. To provide maximum flexibility in dealing with reduced appropri-  
7 ations for fiscal year 2011, the State Board of Education is hereby exempted  
8 from the provisions of Section 67-3511(1), (3) and (4), Idaho Code, for all  
9 moneys appropriated in Section 3 for the period July 1, 2010, through June  
10 30, 2011. Legislative appropriations shall not be transferred from one fund  
11 to another fund, however, unless expressly approved by the Legislature.

12 SECTION 7. LEGISLATIVE INTENT. It is the intent of the Legislature that  
13 by restoring a majority of the 7% reductions and including required contract  
14 inflation--all current medical, dental, veterinary, and residency programs  
15 in Idaho will remain fully intact for fiscal year 2011. For this reason the  
16 State Board of Education may not reduce the number of seats or slots avail-  
17 able in any of the Health Education Programs with the exception of the Op-  
18 tometry Program seats, which can be reduced as determined by the board. The  
19 State Board of Education must maintain the current level of education seats  
20 in all other programs through either increases in student fees, reduction  
21 in costs, or contract renegotiations. Furthermore, it is the intent of the  
22 Legislature that, during fiscal year 2011, the State Board of Education is  
23 directed to review and renegotiate all contracts for the Health Education  
24 Programs in Idaho to allow for contract adjustment in times of fiscal cri-  
25 sis that allow for immediate modification to the program if appropriation  
26 amounts are reduced.

27 SECTION 8. An emergency existing therefor, which emergency is hereby  
28 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-  
29 fect on and after passage and approval.
