A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$3,500,000, or so much thereof as may  
6 be necessary, is appropriated to the Illinois Student  
7 Assistance Commission from the General Revenue Fund to meet its  
8 operational expenses for the fiscal year ending June 30, 2020.

9 Section 10. The sum of \$0, or so much thereof as may be  
10 necessary, is appropriated to the Illinois Student Assistance  
11 Commission from the General Revenue Fund for costs associated  
12 with marketing for the College Illinois! Prepaid Tuition  
13 Program.

14 Section 15. The following named amount, or so much thereof  
15 as may be necessary, is appropriated from the General Revenue  
16 Fund to the Illinois Student Assistance Commission for the  
17 following purpose:

18 To support outreach, research, and  
19 training activities .....3,497,700

1           Section 20. The sum of \$451,341,900, or so much thereof  
2           as may be necessary, is appropriated to the Illinois Student  
3           Assistance Commission from the General Revenue Fund for grant  
4           awards to students eligible for the Monetary Award Program, as  
5           provided by law, and for agency administrative and operational  
6           costs not to exceed 2 percent of the total appropriation in  
7           this Section.

8           Section 25. The sum of \$25,000,000, or so much thereof as  
9           may be necessary, is appropriated to the Illinois Student  
10          Assistance Commission from the General Revenue Fund for  
11          payments to eligible public universities for grants associated  
12          with costs related to the first cohort of students pursuant to  
13          the AIM HIGH grant pilot program.

14          Section 30. The sum of \$10,000,000, or so much thereof as  
15          may be necessary, is appropriated to the Illinois Student  
16          Assistance Commission from the General Revenue Fund for  
17          payments to eligible public universities for grants associated  
18          with costs related to the second cohort of students pursuant  
19          to the AIM HIGH grant pilot program.

20          Section 35. The sum of \$26,400, or so much thereof as may  
21          be necessary, is appropriated from the Education Assistance  
22          Fund to the Illinois Student Assistance Commission for costs

1 associated with the Veterans' Home Nurses' Loan Repayment  
2 Program pursuant to Public Act 95-0576.

3 Section 40. The sum of \$264,000, or so much thereof as may  
4 be necessary, is appropriated from the Education Assistance  
5 Fund to the Illinois Student Assistance Commission for grants  
6 to eligible nurse educators to use for payment of their  
7 educational loan pursuant to Public Act 94-1020.

8 Section 45. The following named sums, or so much thereof  
9 as may be necessary, respectively, are appropriated from the  
10 Education Assistance Fund to the Illinois Student Assistance  
11 Commission for the following purposes:

12 Grants and Scholarships

13	For the payment of scholarships to students	
14	who are children of policemen or firemen	
15	killed in the line of duty, or who are	
16	dependents of correctional officers killed	
17	or permanently disabled in the line of	
18	duty, as provided by law .....	1,273,300
19	For payment of Minority Teacher Scholarships .....	<u>1,900,000</u>
20	Total	\$3,173,300

21 Section 50. The sum of \$6,498,000, or so much thereof as  
22 may be necessary, is appropriated from the Education Assistance

1 Fund to the Illinois Student Assistance Commission to the  
2 Golden Apple Scholars of Illinois program, as provided by law.

3 Section 55. The sum of \$439,900, or so much thereof as may  
4 be necessary, is appropriated from the Education Assistance  
5 Fund to the Illinois Student Assistance Commission for the Loan  
6 Repayment for Teachers Program.

7 Section 60. The sum of \$300,000, or so much thereof as may  
8 be necessary, is appropriated from the ISAC Accounts Receivable  
9 Fund to the Illinois Student Assistance Commission for costs  
10 associated with the collection of delinquent scholarship awards  
11 pursuant to the Illinois State Collection Act of 1986.

12 Section 65. The sum of \$110,000, or so much thereof as may  
13 be necessary, is appropriated to the Illinois Student  
14 Assistance Commission from the University Grant Fund for  
15 payment of grants for the Higher Education License Plate  
16 Program, as provided by law.

17 Section 70. The following named sum, or so much thereof  
18 as may be necessary, is appropriated from the Illinois Student  
19 Assistance Commission Contracts and Grants Fund to the Illinois  
20 Student Assistance Commission for the following purpose:

21 To support outreach, research, and

1 training activities .....10,000,000

2 Section 75. The following named sum, or so much thereof  
3 as may be necessary, is appropriated from the Optometric  
4 Licensing and Disciplinary Board Fund to the Illinois Student  
5 Assistance Commission for the following purpose:

6 Grants and Scholarships

7 For payment of scholarships for the

8 Optometric Education Scholarship

9 Program, as provided by law .....50,000

10 Section 80. The following named sum, or so much thereof  
11 as may be necessary, is appropriated from the National Guard  
12 and Naval Militia Grant Fund to the Illinois Student Assistance  
13 Commission for the following purpose:

14 Grants and Scholarships

15 For payment of Illinois National Guard and

16 Naval Militia Scholarships

17 at State-controlled universities

18 and public community colleges in

19 Illinois to students eligible to

20 receive such awards, as provided by law .....20,000

21 Section 85. The sum of \$100,000, or so much thereof as may  
22 be necessary, is appropriated from the Golden Apple Scholars

1 of Illinois Fund to the Illinois Student Assistance Commission  
 2 for the Golden Apple Scholars of Illinois Program, as provided  
 3 by law.

4 Section 90. The following named sums, or so much thereof  
 5 as may be necessary, respectively, are appropriated to the  
 6 Illinois Student Assistance Commission from the Student Loan  
 7 Operating Fund for its ordinary and contingent expenses:

1           Section 95. The sum of \$2,500,000, or so much thereof as  
2           may be necessary, is appropriated to the Illinois Student  
3           Assistance Commission from the Student Loan Operating Fund for  
4           costs associated with Federal Loan System Development and  
5           Maintenance.

6           Section 100. The sum of \$1,000,000 or so much thereof as  
7           may be necessary, is appropriated to the Illinois Student  
8           Assistance Commission from the Student Loan Operating Fund for  
9           costs associated with the Illinois Designated Account Purchase  
10          Program.

11          Section 105. The sum of \$10,000,000, or so much thereof  
12          as may be necessary, is appropriated to the Illinois Student  
13          Assistance Commission from the Student Loan Operating Fund for  
14          distribution as necessary for the following: for payment of  
15          collection agency fees associated with collection activities  
16          for Federal Family Education Loans, for Default Aversion Fee  
17          reversals, and for distributions as necessary and provided for  
18          under the Federal Higher Education Act.

19          Section 110. The following named sum, or so much thereof  
20          as may be necessary, is appropriated from the Federal  
21          Congressional Teacher Scholarship Program Fund to the Illinois  
22          Student Assistance Commission for the following purpose:



1 For transferring repayment funds collected  
 2 under the Paul Douglas Teacher Scholarship  
 3 Program to the U.S. Treasury .....100,000

4 Section 115. The sum of \$190,000,000, or so much thereof  
 5 as may be necessary, is appropriated from the Federal Student  
 6 Loan Fund to the Illinois Student Assistance Commission for  
 7 distribution when necessary as a result of the following: for  
 8 guarantees of loans that are uncollectible, for collection  
 9 payments to the Student Loan Operating Fund as required under  
 10 agreements with the United States Secretary of Education, for  
 11 payment to the Student Loan Operating Fund for Default Aversion  
 12 Fees, for transfers to the U.S. Treasury, or for other  
 13 distributions as necessary and provided for under the Federal  
 14 Higher Education Act.

15 Section 120. The sum of \$13,000,000, or so much thereof  
 16 as may be necessary, is appropriated from the Federal Student  
 17 Incentive Trust Fund to the Illinois Student Assistance  
 18 Commission for allowable uses of federal grant funds related  
 19 to college access, outreach, and training, including but not  
 20 limited to funds received under the federal Gaining Early  
 21 Awareness and Readiness for Undergraduate Program.

22 Section 125. The sum of \$300,000, or so much thereof as

1    may be necessary, is appropriated from the Federal Student  
2    Incentive Trust Fund to the Illinois Student Assistance  
3    Commission for the John R. Justice Student Loan Repayment  
4    Program.
