A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to the Board
8 of the Trustees of the University of Illinois to meet
9 ordinary and contingent expenses for the fiscal year ending
10 June 30, 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010	601,779,800
18	For State Contributions to Social	
19	Security, for Medicare	9,519,800
20	For Group Insurance	24,337,700
21	For Contractual Services	38,906,600

1	For Travel	244,100
2	For Commodities	2,462,300
3	For Printing	0
4	For Equipment	499,600

16 Section 10. The sum of \$2,445,500, or so much thereof as
17 may be necessary, is appropriated from the Fire Prevention
18 Fund to the Board of Trustees of the University of Illinois
19 for the purpose of maintaining the Illinois Fire Service
20 Institute, paying the Institute's expenses, and providing the
21 facilities and structures incident thereto, including payment
22 to the University for personal services and related costs
23 incurred.

1 Section 15. The sum of \$250,000, or so much thereof as
2 may be necessary, is appropriated from the State College and
3 University Trust Fund to the Board of Trustees of the
4 University of Illinois for scholarship grant awards, in
5 accordance with Public Act 91-0083.

6 Section 20. The sum of \$200,000, or so much thereof as
7 may be necessary, is appropriated from the Emergency Public
8 Health Fund to the University of Illinois for costs and
9 expenses related to or in support of Emergency Mosquito
10 Abatement.

11 Section 25. The sum of \$200,000, or so much thereof as
12 may be necessary, is appropriated from the Used Tire
13 Management Fund to the University of Illinois for costs and
14 expenses related to or in support of mosquito research and
15 abatement.

16 Section 30. The sum of \$472,100, or so much thereof as
17 may be necessary, is appropriated from the Hazardous Waste
18 Research Fund to the University of Illinois for its ordinary
19 and contingent expenses.

20 Section 35. The sum of \$1,000,000, or so much thereof as
21 may be necessary, is appropriated from the General

1 Professions Dedicated Fund to the Board of Trustees of the
 2 University of Illinois for costs associated with the
 3 development, support or administration of pharmacy practice
 4 education or training programs for the College of Medicine at
 5 Rockford.

6 Section 40. In addition to any other amounts
 7 appropriated for such purposes, the following named amounts,
 8 or so much thereof as may be necessary, are appropriated from
 9 the General Revenue Fund to the Board of Trustees of the
 10 University of Illinois for the fiscal year beginning July 1,
 11 2009, pursuant to Title XIV of the American Recovery and
 12 Reinvestment Act of 2009:

13 For Personal Services\$45,518,600

14 Section 45. In addition to any other amounts
 15 appropriated for such purposes, the following named amounts,
 16 or so much thereof as may be necessary, are appropriated from
 17 the General Revenue Fund to the Board of Trustees of the
 18 University of Illinois for the fiscal year beginning July 1,
 19 2009, pursuant to Title XIV of the American Recovery and
 20 Reinvestment Act of 2009:

21 For Personal Services\$7,827,500

22 Section 99. Effective date. This Act takes effect July 1,
