A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof as  
6 may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated from the General Revenue  
8 Fund to the Department of Veterans' Affairs:

1 Section 5. The sum of \$750,000, or so much thereof as may  
 2 be necessary, is appropriated from the General Revenue Fund  
 3 to the Department of Veterans' Affairs for all costs associated  
 4 with the Veterans' Accountability Unit.

5 Section 10. The following named amounts, or so much thereof  
 6 as may be necessary, are appropriated from the General Revenue  
 7 Fund to the Department of Veterans' Affairs for the objects and  
 8 purposes and in the amounts set forth as follows:

9 GRANTS-IN-AID

10	For Bonus Payments to War Veterans and Peacetime	
11	Crisis Survivors .....	198,000
12	For Providing Educational Opportunities for

16 Section 15. The sum of \$3,500,000, or so much thereof as  
 17 may be necessary, is appropriated from the General Revenue Fund  
 18 to the Department of Veterans' Affairs for the payment of  
 19 scholarships to students who are dependents of Illinois  
 20 resident military personnel declared to be prisoners of war,  
 21 missing in action, killed or permanently disabled, as provided  
 22 by law.

1 Section 20. The following named amount, or so much thereof  
 2 as may be necessary, is appropriated from the General Revenue  
 3 Fund to the Department of Veterans' Affairs for the object and  
 4 purpose and in the amount set forth below as follows:

5 For Cartage and Erection of Veterans'  
 6 Headstones, including Prior Years Claims .....425,000

7 Section 25. The amount of \$250,000, or so much thereof as  
 8 may be necessary, is appropriated from the General Revenue Fund  
 9 to the Department of Veterans' Affairs for costs associated  
 10 with the Illinois Warrior Assistance Program.

11 Section 30. The amount of \$16,500,000, or so much thereof  
 12 as may be necessary, is appropriated from the General Revenue  
 13 Fund to the Department of Veterans' Affairs for costs  
 14 associated with the Illinois Veterans' Home at Chicago.

15 Section 31. The amount of \$1,000,000, or so much thereof  
 16 as may be necessary, is appropriated from the Illinois Veterans  
 17 Assistance Fund to the Department of Veterans' Affairs for  
 18 costs associated with the Chicago Veterans' Home.

19 Section 35. The amount of \$2,000,000, or so much thereof  
 20 as may be necessary, is appropriated from the Illinois Veterans  
 21 Assistance Fund to the Department of Veterans' Affairs for

1 making grants, funding additional services, or conducting  
2 additional research projects relating to veterans' post  
3 traumatic stress disorder; veterans' homelessness; the health  
4 insurance cost of veterans; veterans' disability benefits,  
5 including but not limited to, disability benefits provided by  
6 veterans service organizations and veterans assistance  
7 commissions or centers; and the long-term care of veterans.

8 Section 40. The following named amount, or so much thereof  
9 as may be necessary, is appropriated from the Illinois  
10 Affordable Housing Trust Fund to the Department of Veterans'  
11 Affairs for the object and purpose and in the amount set forth  
12 as follows:

13 For Specially Adapted Housing for Veterans .....240,000

14 Section 45. The amount of \$250,000, or so much thereof as  
15 may be necessary, is appropriated from the Illinois Military  
16 Family Relief Fund to the Department of Veterans' Affairs for  
17 the payment of benefits authorized under the Survivor's  
18 Compensation Act.

19 Section 50. The following named amounts, or so much thereof  
20 as may be necessary, respectively, are appropriated to the  
21 Department of Veterans' Affairs for objects and purposes  
22 hereinafter named:
