13 Section 15. The sum of 614,000, or so much thereof as 14 may be necessary, is appropriated from the General 15 Professions Dedicated Fund to the Board of Trustees of 16 Chicago State University for all costs associated with the 17 development, support or administration of pharmacy practice 18 education or training programs.

19 Section 20. In addition to any other amounts 20 appropriated for such purposes, the following named amount, 21 or so much thereof as may be necessary, is appropriated from 22 the General Revenue Fund to the Board of Trustees of Chicago
