DIGEST

Islamophobia. Defines "Islamophobia". Provides that Islamophobia is a discrimination on the basis of race, creed, religion, or national origin.

- 1 Page 1, between lines 16 and 17, begin a new paragraph and insert:
2 **"(b) As used in this section, "Islamophobia" refers to the**
3 **definition that was adopted by the United Nations at the 46th**
4 **Session of the United Nations Human Rights Council in November**
5 **2020, which states: Islamophobia is a fear, prejudice and hatred of**
6 **Muslims that leads to provocation, hostility, and intolerance by**
7 **means of threatening, harassment, abuse, incitement, and**
8 **intimidation of Muslims and non-Muslims (including Christians**
9 **and Arabs), both in the online and offline world. Motivated by**
10 **institutional, ideological, political, and religious hostility that**
11 **transcends into structural and cultural racism, it targets the**
12 **symbols and markers of being a Muslim."**
13 Page 1, line 17, delete "(b)" and insert "(c)".
14 Page 2, line 27, delete "(c)" and insert "(d)".
15 Page 2, between lines 29 and 30, begin a new paragraph and insert:
16 **"(e) Islamophobia, whether expressed by an individual or**
17 **through an institutional policy, is discrimination on the basis of**
18 **race, creed, religion, or national origin."**
19 Page 3, between lines 3 and 4, begin a new paragraph and insert:
20 **"(b) As used in this section, "Islamophobia" refers to the**
21 **definition that was adopted by the United Nations at the 46th**
22 **Session of the United Nations Human Rights Council in November**
23 **2020, which states: Islamophobia is a fear, prejudice and hatred of**
24 **Muslims that leads to provocation, hostility, and intolerance by**
25 **means of threatening, harassment, abuse, incitement, and**
26 **intimidation of Muslims and non-Muslims (including Christians**
27 **and Arabs), both in the online and offline world. Motivated by**

1 **institutional, ideological, political, and religious hostility that**
2 **transcends into structural and cultural racism, it targets the**
3 **symbols and markers of being a Muslim."**

4 Page 3, line 4, delete "(b)" and insert "(c)".

5 Page 3, line 32, delete "(c)" and insert "(d)".

6 Page 3, after line 34, begin a new paragraph and insert:

7 **"(e) Islamophobia, whether expressed by an individual or**
8 **through an institutional policy, is discrimination on the basis of**
9 **race, creed, religion, or national origin."**
