MR. SPEAKER:

I move that House Bill 1072 be amended to read as follows:

- 1           Page 1, delete lines 1 through 17.
- 2           Delete pages 2 through 3.
- 3           Page 4, delete lines 1 through 36, begin a new paragraph and insert:
- 4           "SECTION 1. IC 20-19-3-25 IS ADDED TO THE INDIANA CODE
- 5           AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 6           1, 2022]: **Sec. 25. (a) The charter school referendum sharing**
- 7           **account is established.**
- 8           **(b) The charter school referendum sharing account consists of**
- 9           **money transferred to the account under IC 20-43-2-1(b).**
- 10          **(c) Money in the charter school referendum sharing account at**
- 11          **the end of a state fiscal year does not revert for any other purpose**
- 12          **of the state general fund.**
- 13          **(d) The department shall administer the charter school**
- 14          **referendum sharing account. The department shall, after August**
- 15          **1 but before October 1 of each year, distribute any funds in the**
- 16          **account to each charter school according to the distributions**
- 17          **calculated under IC 20-40-3-6 and IC 20-40-20-7.**
- 18          **(e) If the amount in the charter school referendum sharing**
- 19          **account is not sufficient to make the distributions required under**
- 20          **subsection (d) for a particular year, the amount of the distributions**
- 21          **to each charter school must be reduced proportionately."**

42 distribute the amount appropriated by the general assembly for  
43 distribution as state tuition support in accordance with this article. ~~If~~  
44 ~~the appropriations for distribution as state tuition support are more than~~  
45 ~~required under this article, any excess shall revert to the state general~~  
46 ~~fund.~~ The appropriations for state tuition support shall be made each

- 1 state fiscal year under a schedule set by the budget agency and
- 2 approved by the governor. However, the schedule must provide:
- 3 (1) for at least twelve (12) payments;
- 4 (2) that one (1) payment shall be made at least every forty (40)
- 5 days; and
- 6 (3) the total of the payments in each state fiscal year must equal
- 7 the amount required under this article.
- 8 **(b) Any amount appropriated by the general assembly for**
- 9 **distribution as state tuition support that is in excess of the amount**
- 10 **required for distributions under this article or that remains**
- 11 **unexpended and unencumbered at the end of a state fiscal year**
- 12 **does not revert to the state general fund and instead must be**
- 13 **transferred to the charter school referendum sharing account**
- 14 **established by IC 20-19-3-25(a).".**
- 15 Page 18, line 3, delete "a portion of" and insert "**an amount based**
- 16 **on".**
- 17 Page 19, line 13, delete "to distribute" and insert "**will be**
- 18 **distributed".**
- 19 Page 19, line 42, delete "revenue" and insert "**amount".**
- 20 Page 20, line 1, delete "The spending".
- 21 Page 20, delete lines 2 through 5.
- 22 Page 21, line 14, delete "a portion of" and insert "**an amount based**
- 23 **on".**
- 24 Page 21, line 20, delete "to distribute" and insert "**will be**
- 25 **distributed".**
- 26 Page 23, line 4, delete "revenue" and insert "**amount".**
- 27 Page 23, line 5, delete "The spending".
- 28 Page 23, delete lines 6 through 9.
- 29 Renumber all SECTIONS consecutively.
