MADAM PRESIDENT:

I move that Senate Bill 301 be amended to read as follows:

- 1 Page 1, line 4, delete "Legislative Committee for Oversight of".
- 2 Page 1, line 5, after "Services" insert "**Oversight Committee**".
- 3 Page 1, line 7, delete "legislative committee for oversight of child
- 4 services" and insert "**child services oversight committee**".
- 5 Page 1, line 11, delete "legislative committee for oversight of child

- 7 Page 1, line 12, delete "established to:" and insert "**established.**".

- 16 (B) **A child fatality occurs in the child's home.**
- 17 (2) **Recommend to the department policy and process changes**
- 18 **that would improve child safety.**
- 19 (3) **Recommend to the legislative council any necessary**
- 20 **statutory changes that would improve child safety.**
- 21 (4) **Study any topic assigned to the committee by the**
- 22 **legislative council.**
- 23 (5) **Study any other issues relevant to the department's**
- 24 **activities and improving child safety as determined by the**
- 25 **chairperson of the committee.**
