SB 518 # 16

DIGEST

School property tax revenue sharing. Removes provisions requiring all school corporations that adopt a resolution for an operating referendum tax levy after May 10, 2025, to share revenue received from the levy with certain other school corporations. Removes provisions requiring all school corporations to share revenue from the school corporation's operations fund levy with certain other school corporations. Excludes school corporations meeting specified criteria from sharing revenue received from the following: (1) Controlled project levies. (2) School operating referendum levies. (3) School safety referendum levies. (4) School debt service levies. (5) School operations fund levies. Specifies, for purposes of making distributions to charter schools from a controlled project levy, that only charter schools located within the attendance area of the school corporation shall receive a distribution of revenue from that levy. Makes technical and conforming changes.
