*Your Committee on Public Health, to which was referred House Bill 1079, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, line 17, delete "cavity," and insert "**cavity and**".
- 2 Page 2, line 1, delete "area, and adjacent and associated structures;"
- 3 and insert "**area;**".
- 4 Page 2, delete line 2, begin a new line double block indented and
- 5 insert:
- 6 **"(B) diseases, disorders, and conditions of the associated**
- 7 **and adjacent structures of the oral cavity and maxillofacial**
- 8 **area if:**
- 9 **(i) the dentist is providing emergency care; or**
- 10 **(ii) the dentist has completed postgraduate training and**
- 11 **certification in oral and maxillofacial surgery from a**
- 12 **program certified by the Commission on Dental**
- 13 **Accreditation; and"**.

1 Page 2, line 3, delete "(B)" and insert "(C)".

2 Page 5, line 2, delete "licensed under this article may administer"
3 and insert **"may order and administer an immunization that is**
4 **recommended by the federal Centers for Disease Control and**
5 **Prevention Advisory Committee on Immunization Practices for**
6 **individuals who are not less than eleven (11) years of age, if the**
7 **dentist complies with the following requirements:**

8 (1) Before administering an immunization to an individual,
9 the dentist receives the consent of one (1) of the following:

10 (A) If the individual to whom the immunization is to be
11 administered is at least (11) years of age and is less than
12 eighteen (18) years of age, the parent or legal guardian of
13 the individual.

14 (B) If the individual to whom the immunization is to be
15 administered is at least eighteen (18) years of age and has
16 a legal guardian, the legal guardian of the individual.

17 (C) If the individual to whom the immunization is to be
18 administered is at least eighteen (18) years of age and does
19 not have a legal guardian, the individual.

20 A parent or legal guardian who is required to give consent
21 under this subdivision must be present at the time of
22 immunization."

24 Page 5, line 4, delete "(1) is" and insert **"(2) Is"**.

25 Page 5, line 4, delete "resuscitation;" and insert **"resuscitation."**

26 Page 5, line 5, delete "(2) has" and insert **"(3) Has"**.

28 Page 5, line 8, delete "(3) administers" and insert **"(4)**
29 **Administers"**.
