DIGEST OF HB 1004 (Updated March 30, 2015 11:53 am - DI 104)

Citations Affected: IC 16-46.

Synopsis: Safety PIN grant program. Establishes the safety PIN (protecting Indiana's newborns) grant program for the purpose of reducing Indiana's infant mortality rates. Establishes the safety PIN (protecting Indiana's newborns) grant fund. Requires the state department of health to administer the grant program. Sets forth requirements for grant proposals, and sets forth subject matters that will receive preference in awarding the grants.

Effective: July 1, 2015.

ENGROSSED HOUSE BILL No. 1004

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 16-46-14 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]:
4 **Chapter 14. Safety PIN (Protecting Indiana's Newborns) Grant**
5 **Program**
6 **Sec. 1. The safety PIN (protecting Indiana's newborns) grant**
7 **program is established. The state department shall administer the**
8 **program.**
9 **Sec. 2. (a) The safety PIN (protecting Indiana's newborns) grant**
10 **fund is established for the purposes of distributing money for the**
11 **reducing infant mortality grant program. The fund shall be**
12 **administered by the state department.**
13 **(b) The fund consists of:**
14 **(1) money appropriated to the fund by the general assembly;**
15 **(2) money received from state or federal grants or programs;**

- 1 **and**
2 **(3) gifts, money, and donations received from any other**
3 **source, including transfers from other funds or accounts.**
4 **(c) The expenses of administering the fund shall be paid from**
5 **money in the fund.**
6 **(d) The treasurer of state shall invest the money in the fund not**
7 **currently needed to meet the obligations of the fund in the same**
8 **manner as other public money may be invested. Interest that**
9 **accrues from the investments shall be deposited in the fund.**
10 **(e) Money in the fund at the end of a state fiscal year does not**
11 **revert to the state general fund.**
12 **Sec. 3. (a) A person seeking a grant under this chapter must**
13 **submit a proposal to the state department.**
14 **(b) A proposal for a grant under this chapter must include the**
15 **following:**
16 **(1) The targeted area.**
17 **(2) Measurable behavioral or secondary outcomes within the**
18 **target area.**
19 **(3) A proposed specific reduction in the rate of infant**
20 **mortality among the targeted area that is measurable based**
21 **on available information to the state department.**
22 **(4) The time frame in which to achieve the reduction**
23 **described in subdivision (3).**
24 **(c) The state department shall determine whether to approve a**
25 **grant proposal. If the state department approves a proposal, the**
26 **initial award amount shall not exceed fifty percent (50%) of the**
27 **total grant amount approved for the proposal. The state**
28 **department shall distribute the remaining amount of the approved**
29 **grant to the grantee when the state department determines that the**
30 **reduction in the infant mortality rate among the proposal's**
31 **targeted area has been achieved within the time frame specified in**
32 **the grant proposal.**
33 **Sec. 4. (a) In awarding grants under this chapter, the state**
34 **department shall give preference to proposals that seek to do any**
35 **of the following:**
36 **(1) Improve access and coordination through outreach and**
37 **follow-up services for pregnant women who are at risk of not**
38 **receiving prenatal care.**
39 **(2) Incentivize at-risk pregnant women to obtain prenatal**
40 **care.**
41 **(3) Decrease smoking rates among pregnant women.**
42 **(4) Promote evidence based home visitation by a trained**

2 (5) Incentivize collaboration between health care providers
3 and other human services providers in providing outreach to
4 at-risk pregnant women.
5 (6) Address the issue of infant mortality on a regional basis.
6 (b) The state department shall develop regions for purposes of
7 subsection (a)(6).
8 Sec. 5. The state department may adopt necessary rules under
9 IC 4-22-2 to implement this chapter.

COMMITTEE REPORT

Madam President: The Senate Committee on Family and Children Services, to which was referred House Bill No. 1004, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 2, line 17, after "(2)" insert "**Measurable behavioral or secondary outcomes within the target area.**

(3)".

Page 2, line 20, delete "(3)" and insert "**(4)**".

Page 2, line 21, delete "(2)." and insert "**(3)**".

Page 2, delete lines 22 through 28, begin a new paragraph and insert:

"(c) The state department shall determine whether to approve a grant proposal. If the state department approves a proposal, the initial award amount shall not exceed fifty percent (50%) of the total grant amount approved for the proposal. The state department shall distribute the remaining amount of the approved grant to the grantee when the state department determines that the reduction in the infant mortality rate among the proposal's targeted area has been achieved within the time frame specified in the grant proposal."

and when so amended that said bill do pass and be reassigned to the Senate Committee on Appropriations.
