DIGEST OF HB 1042 (Updated January 10, 2024 12:43 pm - DI 140)

Citations Affected: IC 21-12.

Synopsis: Transition to teaching scholarships. Provides that any balance in the next generation Hoosier educators scholarship fund remaining after the award of next generation Hoosier educators scholarships for a fiscal year may be used to fund additional transition to teaching scholarships. Removes a provision concerning the reduction of scholarships if certain limits are exceeded.

Effective: July 1, 2024.

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:
